IMPORTANT—NEW SURCHARGE ON ALL FINES

Every year the Utah State Legislature introduces new statutes for the courts to implement. This year Senate Bill 196 was introduced and passed for Court Security Account funding. The statute number is 78-5-116.5 and it went into effect on May 3, 2004.

78-5-116.5 Security Surcharge—Application—Deposit in restricted accounts.

This statute is certainly worth reading through, but because of its length, I will highlight only the first two sections, which explain what is being done.

(1) In addition to any fine, penalty, forfeiture, or other surcharge, a security surcharge of \$32.00 shall be assessed on all convictions for offenses listed in the uniform bail schedule adopted by the Judicial Council and moving traffic violations.

(2) The security surcharge shall be collected and distributed pro rata with any fine collected. A fine that would otherwise have been charged may not be reduced due to the imposition of the security surcharge.

Sections Three and Four go on to explain how the surcharge is allocated for the governmental entity.

What does this mean to offenders? Whether the charge is for traffic, wildlife, parks, or other criminal offenses, a \$32.00 surcharge is added to the fine amount due and cannot be suspended by the court, nor can the fine amount given by the court be reduced by the \$32.00. An example would be an alcohol open container ticket. The bail on this offense was \$100.00. With the new surcharge the cost is now \$132.00. A \$50.00 speeding ticket is now \$82.00, and a \$45.00 no-seatbelt ticket is now \$77.00. This applies per charge, not per ticket. Therefore, if you have a speeding violation and an expired registration, \$32.00 will be added to each charge written.

Tickets received before May 3, 2004 are not subject to the additional \$32.00 amount, but all citations issued after the May 3, 2004 date are required to pay the \$32.00 amount in addition to the regular fine.

Allocation of the monies collected from this surcharge are discussed in statute 78-5-116.7 as well.

Many people are not sure where to search for statutes. Your county building, local court, (the internet at: <http://www.le.state.ut.us/~code/code.htm>)

or public library will have copies of the Utah State Code and if you need assistance finding the code, someone can show you how to find the statutes listed numerically.

BANK OFFERS UNIQUE LOANS

South Jordan, Utah - Utah Business Lending Corporation, a non-profit corporation based in South Jordan, is a new source of funding for Utah businesses seeking loans in the \$10,000 to \$50,000 range. The program is designed to support businesses in rural communities, and all loans are to be secured by improved real estate.

Gordon Holt, trustee of Utah Business Lending Corporation said, “We are filling a unique segment of the market, providing small start-up loans to individuals and private organizations.”

“Applicants should demonstrate an ability to save jobs or to create employment and community development opportunities. These loans are only available in cities that do not exceed 25,000 in population. ... Potential borrowers need a viable business plan and also should demonstrate an inability to secure financing elsewhere at reasonable rates and terms.”

Borrowers will be given an entrepreneurial assessment of their personal business skills. As a condition of the loan, they may be asked to take a course of study which may include business-related college classes or a 12-week course called Nx Level. The lender will reimburse the cost of these classes upon satisfactory completion of studies.

“Small loans at attractive rates are difficult to find,” says Holt. “Many Banks in Utah set \$50,000 as their lowest point for business loans. Additionally, we are planning to make more than 30 percent of our loans to under-represented groups. These include Native Americans, minorities, female-owned businesses and poverty level families with income less than \$24,600.”

The bank will provide loans for business acquisition, construction or modernization and for the purchase of equipment and supplies. They will also provide working capital for entrepreneurs. The bank will not underwrite agriculture production, golf courses, investment institutions or community antenna television services.

WEST NILE VIRUS BIRD TESTING UNDERWAY

Salt Lake City, Utah - The Division of Wildlife Resources announces the beginning of wild bird surveillance for West Nile virus in Utah. Wild bird surveillance began May 15, 2004 and will continue until October 15, 2004 as needed.

Wild birds are important indicators of West Nile viral activity in a given area and viral activity in birds is often detected before human illness. This early detection provides health officials another opportunity to inform people in newly infected areas of preventative measures they can take to protect themselves and their horses. The division encourages the public to participate in this program. If you see an ill or dead bird in your area displaying the symptoms or meeting the specifications below, please contact Ron Stewart at the Division of Wildlife Resources Office in Vernal at 435 781-9453.

Target Species for testing in 2004 include birds of the Corvid family (ravens, crows, jays, magpies, etc.) Raptors and other discretionary species that may be exhibiting neurological symptoms (examples include birds that can't fly or that appear disoriented and lethargic).

Please visit the division's website for photos of the (http://www.wildlife.utah.gov/wnv/bird_id.html) birds that will be tested this year.

It is important to note that not all birds may be suitable for testing. To determine if a bird is suitable for testing, please follow these guidelines:

- Is the bird a target species (raven, crow, jay magpie, or bird of prey and is the bird dead, dying or appear to be ill)?
- If dead, has the bird been dead for less than 24 hours (evidence of decay would indicate the bird has been dead longer than 24 hours and is therefore not suitable for testing)?
- Is there no other obvious cause of death (window strike, cat-kill or collision with a vehicle)?

For those with access to the internet, the Division of Wildlife Resources has provided an online submission form to make reporting dead birds more convenient. More information regarding wild bird surveillance, including a bird identification page and the online submission form go to the website at: <http://www.wildlife.utah.gov/wnv/>.

The Division of Wildlife Resources is working closely with other state and local agencies involved in West Nile surveil-

lance and prevention, including the Utah Department of Health, the Utah Mosquito Abatement Association and the Utah Department of Agriculture and Food.

Since people may become infected with WNV through the bite of an infected mosquito, personal protection is the key. WNV in humans can result in serious disease or death, so it is important to follow these recommended guidelines:

- Protect yourself from dusk to dawn. Mosquitoes that carry WNV are most active during this time.
- Use mosquito repellent with DEET according to label instructions.
- Make sure window screens and screened doors are in good repair. Small holes will allow mosquitoes to enter.
- Follow Mosquito Abatement District suggestions as outlined below and call if you notice large mosquito swarms or larvae.

MOSQUITO DISTRICT GETS GRANT

The Daggett County Mosquito Abatement District was awarded a \$25,000 grant to help with the Mosquito problem this summer. The strategy is to find and destroy mosquito larvae before they become biting, egg laying adults. This is where you can help. Please:

1. Find and eliminate standing pools of water on your property including tires, birdbaths, outdoor pet dishes, etc.
2. Do NOT allow waste water to pool and stand idle. As many as ten million mosquitoes can be produced on just one acre of land that has been flooded with irrigation water. The same acre will produce MILLIONS of mosquitoes with EACH irrigation cycle all season long or
3. Establish drainage lines to remove excess water, and
4. Call Lesa (784-3222) of the Mosquito Abatement District if you have standing pools that cannot be drained, at the BEGINNING of each irrigation cycle, or when you discover a large number of larvae or mosquitoes.

A call BEFORE mosquitoes are allowed to escape from standing water will prevent a call later telling us the mosquitoes you have produced are making your outdoor activities unbearable. It is the responsibility of EVERY citizen who produces mosquitoes on their property to help ensure the health and well-being of not only their family, but of their neighbors and the general public. A simple phone call helps everyone!!

LEPC TIP OF THE MONTH

JUST AN LEPC NOTE** The LEPC meeting for the Month of June will be held on June 17th at 14:00 at the Courthouse come and join us.

This month is Lightning Safety month. Did you know the following?

- Lightning causes an average of 80 fatalities and 300 injuries each year.
- Lightning occurs with **all** thunderstorms; each year lightning strikes the Earth 20 million times.
- The energy from one lightning flash could light a 100-watt light bulb for more than 3 months.
- Many fires in the western United States and Alaska are started by lightning.
- The air near a lightning strike is heated to 50,000 degrees F- hotter than the surface of the sun.

The following was presented to the LEPC last month by Jim Pringle from the Grand Junction National Weather Service.

NO PLACE OUTSIDE IS SAFE WHEN THUNDERSTORMS ARE IN THE AREA

- Plan your outdoor activities to avoid thunderstorms. Listen to NOAA Weather Radio for the latest forecast before heading out.
- 30/30 rule – if the time between lightning and thunder is 30 seconds or less go to a safe shelter. Stay there until 30 minutes after the last rumble of thunder.
- A safe shelter during lightning is inside a fully enclosed, substantial building or a vehicle with a solid metal roof.
- Indoors – stay away from anything connected to power, telephone, and cable lines. Remote controls and cordless phones are okay. Stay away from water or plumbing.
- Outdoors – Stay away from high places, open areas (including golf courses and other sports fields) and tall isolated objects. Avoid open structures such as picnic shelters. Make sure you leave enough time to get to safe shelter.

WILDLIFE OF FLAMING GORGE-CATS?

The moon cast her lovely glow over the landscape, illuminating the Flaming Gorge Dam as I drove slowly across it, and highlighted a peculiar sight. Running delicately down the center line was a small animal. "A cat," I thought. But a second glance showed that this was not a cat—yet, what was it? A fluffy black and white ringed tail, as long as its thin, lithe body; rounded ears above a masked, ferret-like face which seemed to have a look of permanent surprise as the animal turned toward my car's headlights; why, it was a ringtail cat! It scampered boldly in front of me. Reaching the rocky cliffs beside the Dam, it jumped, insect-quick, into the shadows and disappeared into a rock crevice.

Ringtails (or cacomistles, as they are sometimes called) are a nocturnal mammal that comprise a portion of Flaming Gorge's more unusual fauna. Rarely seen, but what a delight when they are glimpsed! Known as "miner's cats" they surpass domestic felines in catching mice and rats. Omnivorous in their tastes, they will also eat birds, lizards, insects, fruit and eggs. In the spring, the females bear kittens which do not open their eyes until they are over a month old. Then, it is a constant battle for them to avoid Horned Owls, coyotes and rattlesnakes when they leave their den to live on their own.

A local Forest Service employee set a live-trap to catch what he thought was a skunk inside their warehouse. Imagine the surprise when a ringtail made its appearance in the trap the next day! The ringtail regally surveyed the inquisitive onlookers with large, white-ringed dark eyes before it was released into the rock cliffs. It looked so docile that one well-intentioned gentleman put his finger through the bars to touch it. It instantly gave him a swift nip to remind him that it was not a pet!

Drive carefully at night by the rock walls of Dutch John, and you, too may be rewarded with the sight of a pair of glowing green eyes and a waving striped plume from the cliffs!

DOUBLE HOMICIDE CASE SETTLED

Park City, Utah - DAGGETT COUNTY DOUBLE MURDER CASE SETTLED WITHOUT TRIAL.

Lewis Heffelfinger, 56, pleaded guilty to two counts of capital murder and was sentenced to two consecutive terms of life in prison without the possibility of parole. Michael Heffelfinger, 25, received the same sentence after accepting the same plea deal last month. By pleading guilty, both killers spared themselves the possibility of a death penalty sentence.

October 21, 2001, both men from Albuquerque, New Mexico, shot and killed Kelly Carter and Brad Gross of Vernal Utah. The murders took place in Dutch John Draw in Daggett County.

Both victims families were consulted before the plea agreement was reached. "I'm glad this day is finally here and done," said Charlene Gross, the mother of Brad Gross. "A sure-fire way to make sure they spend the rest of their lives in prison."

At the hearing, Daggett County Sheriff's Deputy Bryan Smith, the lead investigator on the case, was asked to read a statement directed at Lewis Heffelfinger, and written by the victims' families.

May 24th, 2004 - Daggett County Sheriff's Office received it's new Mobile Command Center. The vehicle was built for Daggett County by LDV, Inc. of Burlington Wisconsin, at a cost of \$111,271.00. The entire cost of the vehicle was paid for by a grant from Homeland Security.



The Command Center is equipped with: three work/computer stations, phone and fax lines, a base radio station which is programmable to other frequencies, a refrigerator, microwave, coffee pot, toilet facilities and a generator.

The vehicle will be used at remote locations in Daggett County when a command post needs to be set up for a crime scene, natural disaster, hazmat spill, forest fire or terrorist incident.



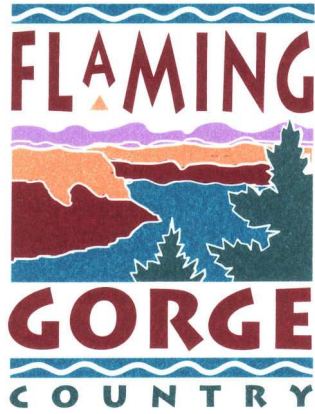

WILDLIFE AND RIVERS FESTIVAL - JUNE 10TH THROUGH THE 13TH

A year of planning has gone into preparation for the 1st Annual Wildlife and River's Festival. The Festival was designed to celebrate the "unique and diverse wildlife, spectacular geology, and rugged beauty of Northeastern Utah and its rivers." Events will be held all over the Tri County area, including many here in Daggett County.

Thursday morning, June 12th, is the registration for the Plein Aire Art Competition and the Uinta Mountain Digital Shootout. Both competitions will take place throughout the day Thursday and Friday, with judging on Saturday and awards on Sunday. Digital photos can be taken and art created anywhere in the Tri County area during this time. There are three youth divisions that are free and an open division with a registration fee of \$35.00.
