Agenda Item 5A Practice

CMA medication administration & request to approve additional injectable medications for ANP's to delegate to CMAs

Ms. Brenda Cook from the Southcentral Foundation reported that they have updated the medication training for CMAs. They employed a learning specialist to improve the format, but leave the content the same. They currently have a 6 week class for new CMAs. Tests are different every year.

Ms. Cook presented a request for additional injectable medications to be delegated by ANP's to CMAs. The Board discussed the proposal.

Beginning January 2013 Southcentral Foundation will annually submit a medication administration report of adverse events of injectable medications delegated by ANPs to CMAs.

Kara Case submitted an email requesting the administration of a sub-hypnotic dose of propofol by RNs to patients with severe post operative nausea and vomiting.

Captain Finley, Dr. JoAnn Bartley, and Pamela of the Clithroe Center presented information about their residential treatment center. Their question is who is able to care for the detox clients? Who is able to administer the CIWA and COWS assessment forms? Clithroe has 5 full time nurses. The board reviewed the Detox material presented by Salvation Army Clithroe Center and determined further information, (such as each site unit policy), is necessary prior to any approval of expansion of the LPN scope of practice.

The question regarding out-of-state field trips and school nurses delegating to a UAP was addressed. It was advised that a power of attorney is an option for the parent or guardian to sign prior to the field trip. The other option is to have the parent delegate to someone on the

field trip the management of their child's health needs. The school nurse can teach the field trip's UAP after the parent has delegated to the UAP. By using one of these methods the school nurse is not delegating to a UAP.
