____ **TREASURER (Has been a minimum of a two year commitment. In charge of collecting dues and all financial records and reports.)**

____ **PARLIAMENTARIAN (Assists officers where needed.)**

Advisory Committee-last two past-presidents.

You would attend your respective committee meeting at the Summer AR ACTE/DWE Conference Sun. afternoon and you would give a report at the AATFACS Business Meeting the Mon. of the Summer Conference.

All officers/committee chairs should attend the AATFACS Board Meetings-1 in the Fall, 1 in the Spring, 1 in June-usually when school is out, and the Summer AR ACTE/DWE Conference. We all normally attend the FACS division summer conference as well. All officers/committee chairs have voting privileges. Currently the President and Past-President are also the AATFACS (FACS division of AR ACTE) AR ACTE Board representatives. If we get 200 members, then we would be able to add another board position which would most likely be the President-Elect. So those officers would also have to attend AR ACTE Board Meetings-one in the Fall and one in the Spring and of course, the Summer AR ACTE/DWE Conference.

Note: Sometimes the AATFACS Board Meetings are on Saturday. The Current President sets up the Board Meetings. If they are on a week day, they are normally held at the AR DWE, Luther Hardin Building, Little Rock. If on a Sat., a central location is usually chosen.

Many school districts support their teacher participating in professional organizations as an officer/board member. You should find out if you would be able to have the time as school business to attend the meetings. Some you would already be attending as a part of Professional Development/Inservice.
