

# Green Building Innovation Showcase

### **EXHIBITORS' REGISTRATION RULES & REGULATIONS**

#### GENERAL RULES:

- All rules and regulations relative to public buildings as prescribed by fire Regulations for the City of Calgary will be adhered to. All codes pertaining to liquor, health, city ordinates, safety and electrical both provincial and municipal, must be adhered to.
- The exhibitor agrees to abide by all regulations and rules adopted by the Alberta Chapter - Canada Green Building Council in the best interest of the Showcase and agrees that the Alberta Chapter -Canada Green Building Council shall have the final decision in adopting any rules or regulations deemed necessary prior to, during and after the show.

#### **BOOKING SPACE & PAYMENT:**

- Green Building Innovation Showcase (THE SHOWCASE) fees are due upon application.
- Upon payment, showcase participants will be assigned a booth number and all bookings are on a "FIRST COME FIRST SERVED BASIS."
- Display space booking requests will be honoured as best as possible by the event organizer; however, specific display allocations cannot be guaranteed.
- There are a limited number of display spaces available; book early to avoid disappointment.
- Organizers reserve the right to alter the size of unsold spaces.

#### CANCELLATION:

- Cancellation of space must be in writing and received by the Alberta Chapter Canada Green Building Council more than 15 days prior to the Showcase.
- In the event of a cancellation 30 days prior to the show, the full application fee will be refunded, less a \$100.00 administration fee.
- After 30 days, but prior to 15 days of the show, the exhibitor will forfeit 70% of the total application fee.
  - If the exhibitor cancels within 15 days prior to the show, 100% of the application fee will be forfeited.

#### WAIVER OF LIABILITY AND INDEMNITY:

The Alberta Chapter - Canada Green Building Council and its partners will exercise reasonable precautions for the protection of property of exhibitors, but shall assume no responsibility for loss and or damage of the property of the exhibitors placed in the exhibit area or adjacent grounds and is discharged from all responsibilities.

Exhibitors shall be liable for any and all damages he/she may cause. It is understood and agreed by the exhibitor that The Alberta Chapter -Canada Green Building Council may cancel said SHOWCASE, and may cancel this contract if, in the opinion of The Alberta Chapter - Canada Green Building Council and its partners, such show would be impractical and/or inadvisable to continue.

#### INSURANCE:

It is the responsibility of each exhibitor to supply and purchase his or her own insurance coverage.

#### DISPLAY EXHIBITOR DELEGATE REGISTRATION:

One (1) discounted delegate registration per display registration will be offered for purchase. Any additional delegates must be registered through the online registration process at the posted rates.

#### MANNING DISPLAYS:

All exhibits must remain intact throughout the THE SHOWCASE's designated exhibition hours. Displays are not required to be manned.

Because the displays are primarily located around the Symposium's plenary session and meal room, discussions with delegates at the displays can only occur during meal breaks, breakout session periods and the reception.

Exhibitors shall cause all such employees, agents, visitors and guests of the exhibitor to be familiar with all rules and regulations of THE SHOWCASE.

### **EXHIBITORS' REGISTRATION RULES & REGULATIONS**

#### MOVE IN/OUT INSTRUCTIONS:

Exhibitors will be able to move in displays into the facility as follows:

- Tuesday, May 10, 6:00 a.m. 7:30 a.m.
- Exhibitors must be set up by 7:30 a.m. when the registration desk for the Symposium opens.

Exhibitors may not dismantle their display booths before May 10, 4:30 p.m. and must remove display booths immediatly after the SHOWCASE ends at 6:00 p.m.

### NOTE:

Earlier move in may be accommodated closer to the event. The event organizer will advise registered exhibitors if this is possible in April/May 2016.

### PLEASE NOTE:

It is preferred that exhibitors load through the loading dock area; however, exhibitors can walk material in through the front doors only if they can <u>hand carry it easily through the doors</u>. NO carts or wheeled units can be used when moving in through the front concourse.

#### ADDITIONAL EXHIBITOR SERVICES

Please refer after January 2016 to the Calgary Stampede to order any additional services such as internet or power. You MUST PRE-BOOK these services directly with the Calgary Stampede.
