Dear Sir or Madam:

The Air Resources Board (ARB) is currently undertaking a survey of architectural coatings sold in California. ARB first mailed this survey in April 2005, with a due date of September 1, 2005. In reviewing the current surveys received to date, we identified your company as not having responded. ***If you sell products covered by this coatings survey in the State of California you are required by law to respond.*** If you do not sell coatings in California please respond by either stating so in writing, or by completing and returning the "Reasons for Not Completing the Survey Form" included in the survey. A copy of this form is enclosed for your convenience. In addition, if you do not manufacture architectural coatings, we will remove you from our mailing list. If you do sell products in California and have not completed the survey, please contact any of the staff listed on the next page immediately for assistance in completing the survey and to avoid possible enforcement action.

This requirement to provide the information requested is made pursuant to sections 39600, 39607, 39701 and 41511 of the California Health and Safety Code, and Title 17, California Code of Regulations, section 91100. State law requires that you respond if you sell products in California. Information, which you designate as confidential, will be protected in accordance with Title 17, California Code of Regulations, sections 91000 to 91022 and the California Public Records Act (Government Code section 6250 et seq). ***Failure to report or failure to supply complete information for the architectural coatings survey may result in a report of violation being issued to your company.***

ARB staff worked extensively with industry representatives over several months to develop this architectural coatings survey. Your participation in this survey is important. ARB last conducted an architectural coatings survey in 2001 to collect 2000 data. ARB is conducting this survey to quantify recent changes and advances in coating formulations, as well as to collect data necessary to explore a reactivity-based control strategy for architectural coatings. Findings from this survey will be used to update California's emission inventory. In addition, your response ensures that your industry receives credit for emission reductions already achieved, and that categories experiencing technical problems in meeting existing limits are considered for further review.


