

## **BASIS AND PURPOSE OF RULE 6.MO**

The purpose for Rule 6.MO is to provide specific game details and requirements for Colorado Lottery Game Number 182, "TIC TAC TOE", such as numbers and sizes of prizes, the manner of selecting and validating winning tickets and the allocation of total revenues amongst prizes and costs. The statutory basis for Rule 6.MO is found in C.R.S. 24-35-208 (1)(a) and (2), and 24-35-212.

### **RULE 6.MO COLORADO LOTTERY GAME NUMBER 182**

#### **6.MO.1 Instant Winning Lottery**

An instant winner game to be called the Colorado Lottery Game Number 182, "TIC TAC TOE", is authorized to be conducted by the Director under the following Rules and Regulations, Rule 5 and under such further instructions and directives as the Director may issue in furtherance thereof.

#### **6.MO.2 Definitions**

In addition to the definitions provided by Rule 1.2 and Rule 5, and unless these Rules and Regulations for Colorado Lottery Game Number 182 otherwise require, Play Symbols, Prize Symbols, Legends, Identifiers, Play Symbol Captions, Prize Symbol Captions, and Retailer Validation Codes are as set forth in Paragraph 6.MO.9 and Exhibits A through C of this Rule 6.MO.

#### **6.MO.3 Determination of Instant Prize Winners**

An instant prize winner for Colorado Lottery Game Number 182 shall be determined as follows and as set forth in Exhibit A:

- a) For the purposes of determining a winning ticket a "Line" shall consist of three (3) Play Symbols in a horizontal row, vertical column or diagonal within one of four grids consisting of nine (9) Play Spots. The holder of a winning ticket may win on any of the four (4) Tic Tac Toe games shown on the front of the ticket. Play Symbols may not be interchanged among the four games.
- b) The holder of a ticket on which three (3) of the ten (10) "Your Numbers" Play Symbols with corresponding caption match the Play Symbols in an entire horizontal row, vertical column or diagonal (top left to bottom right or top right to bottom left) of any 9 Play Spot grid shall be entitled to the dollar amount printed on the ticket adjacent to that "Line".
- c) Players may win up to four (4) times, one time per game, on a ticket in Colorado Lottery Game Number 182.
- d) In all events, the determination of prize winners shall be subject to the general ticket validation requirements set forth in Paragraph 5.17 of Rule 5, Paragraph 6.MO.8, and the requirements set out on the back of each instant ticket.

#### **6.MO.3.1 Determination of Eligible Drawing Entries**

The holder of any ticket which does not win an instant cash prize shall be entitled to an entry into a drawing in which one additional cash prize of \$50,000 will be awarded as set forth in Exhibit B of this rule.

#### **6.MO.4 Claim Period and Payment of Prizes**

- a) All instant "cash" prizes must be claimed within 180 days after the announced end of the game.
- b) The holder of any \$2, \$4, \$5, \$10, \$20, \$30, \$40 or \$50 prize-winning ticket may take it to any Lottery retailer location, mail it to Lottery Headquarters as provided on the ticket back or deliver the ticket to any Lottery Claims Center for validation and subsequent payment. The holder of any \$100 or \$200 prize-winning ticket may mail it to Lottery Headquarters or deliver the ticket to any Lottery Claims Center for validation and subsequent payment. Lottery retailers, at their option, may accept \$100 or \$200 prize-winning tickets for validation and payment.
- c) The holder of a \$1,000, \$5,000, \$10,000 or \$50,000 prize-winning ticket shall fill out a claim form and send the completed form and the ticket to the Lottery for validation and payment pursuant to instructions on the back of the ticket or deliver the ticket to any Lottery Claims Center for validation and subsequent payment.
- d) The holder of a ticket eligible for entry into a drawing must send the ticket to the Colorado Lottery in accordance with the instructions listed on the back of the ticket. Non-cash-winning tickets received at the Colorado Lottery within 60 days after the announced end of the game shall be entered into a drawing to be conducted in accordance with drawing guidelines and procedures approved by the Lottery Commission.
- e) Any cash prize from a winning ticket that is not claimed within the period specified herein and in the manner specified on the back of each ticket shall remain the property of the Lottery.
- f) The owner of the ticket that is drawn to win the drawing prize shall be required to fill out a claim form and send it to the Lottery in order to receive the prize.

#### **6.MO.5 Price of Tickets for Colorado Lottery Game Number 182**

The purchase price of each ticket for Colorado Lottery Game Number 182 shall be \$2.00. However, a licensed retailer may be permitted, upon prior approval of the Director, to make gifts of tickets as a means of promoting the sale of goods or services to the public.

6.MO.6 **Numbers and Sizes of Prizes for Colorado Lottery Game Number 182 - Instant Prizes**

The numbers (plus five percent or minus three percent [+5% or - 3%]) and sizes of instant prizes are as set forth in Exhibit B attached to this Rule 6.MO and incorporated by reference as though fully set forth herein. Overall odds of winning include break-even prizes.

6.MO.7 **Manner of Selecting Winning Tickets**

- a) The winning of any instant cash prizes in the amounts set forth in this rule results from ticket purchases by the public and removal by the ticket holder of the rub-off area revealing a winning combination of play symbols with corresponding captions as set forth in Paragraph 6.MO.3. In addition, to be a valid instant cash winning ticket, all of the requirements of Paragraph 5.17 of Rule 5 and 6.MO.8 must be satisfied.
- b) The winning of the drawing prize set forth in Paragraph 6.MO.3.1 shall be determined at a publicly held drawing.
- c) The drawing shall be conducted at a time and place to be announced and pursuant to methods to be announced by the Lottery Director. The Director reserves the right to change any of the foregoing at any time.
- d) Participants in the drawing process, which may include preliminary and final drawings, shall be those holders of valid non-cash winning tickets that have all required information provided and are claimed in accordance with 6.MO.4.
- e) Tickets with disputed ownership will not be entered into the drawing process. Rule 5.5, "Ownership of Tickets", shall govern Lottery actions in all questions of ticket ownership.

6.MO.8 **Ticket Validation Requirements for Colorado Lottery Game Number 182**

In addition to meeting all of the requirements in these Rules and Regulations, Paragraph 5.17 of Rule 5, and those printed on the back of each ticket, to be a valid instant winning ticket, the number and placement of Play Symbols on the ticket must conform precisely to those in Exhibit A and the Play Symbols, Legends, and Retailer Validation Codes must be present in their entirety and must conform to those in Exhibit C attached to this Rule 6.MO and incorporated by reference as though fully set forth herein.

6.MO.9 **Play Symbols, Prize Symbols, Legends, Identifiers, Play Symbol Captions, Prize Symbol Captions, and Retailer Validation Codes for Colorado Lottery Game Number 182**

Play Symbols, Legends and Retailer Validation Codes are as set forth in Exhibit C attached to this Rule 6.MO and incorporated by reference as though fully set forth herein.

Retailers have the option of paying up to \$599. Claim prizes of more than \$599 by mail claim form obtainable at Lottery retailers to P.O. Box above or claim at a Lottery Office. Ticket within 180 days of announced end of game. Ticket purchasers must be at least 18 years old. information. All cash prizes not claimed within 180 days after end of game are forfeited. All are subject to Lottery Rules and State Law. Tickets are void and not entitled to prize payment if game rules or are irregular in any manner. Liability for a void ticket is limited to replacement price. Availability of prizes subject to prior sale.
