Eligibility Requirements and Rules for Use of Lease	d Horses	
<ul> <li>A "Leased" horse is any horse that is not owned by the 4-H'er or his/her immediate family (parents, siblings, guardians). Horses owned by distant family—aunts, uncles, cousins or grandparents—are considered leased horses.</li> <li>The objective of a leased horse project is to allow 4-H'ers who do not own a horse to learn the skills of feeding, management, care, and training of horses. Through this experience they also learn the skills of decision-making, information gathering, communication, responsibility, and self-confidence.</li> <li>All horses, including leased horses, must be identified in 4hOnline by May 15.</li> <li>Exhibitors must meet all requirements included in 4-H 202.</li> <li>Animals identified as part of a 4-H project cannot also be identified or exhibited as an FFA project or vice versa.</li> <li>A 4-H'er is allowed to lease a maximum of two (2) horses.</li> <li>Leased horses are not eligible to exhibit in conformation (halter) classes because the 4-H'er did not select the animal from others based on its conformation. They are eligible to exhibit in</li> </ul>	<ul> <li>halter showmanship, riding and driving classes, because these classes are judged on the 4-H'er's ability to exhibit the animal, not on the quality of the animal.</li> <li>The 4-H'er agrees to provide a majority of the management, care, and training for this horse. This includes, but is not limited to, the management, proper feeding, grooming, exercising, health and veterinary expenses, farrier services, exhibitors fees, training, boarding, etc.</li> <li>The 4-H'er agrees to make all reasonable efforts to keep the horse in safe stalls, pastures, or corrals, and to care for the horse as if he or she was the legal owner. The 4-H'er has the right to ride and exhibit this horse in all 4-H related activities.</li> <li>The 4-H'er is expected to manage and care for this horse at least from May 15 through the end of the exhibiting season (county fair, state fair or Ak-Sar-Ben).</li> <li>lowa 4-H reserves the right to disqualify leased horses of own ers who have previously violated 4-H rules.</li> </ul>
