COURSE DESCRIPTION

Swallowing and feeding impairments have been diagnosed with increased frequency in children and adults in recent years and are complex and challenging. This dynamic full-day seminar brings together a team of adult and pediatric specialists to discuss diagnosis and treatment of individuals of all ages with feeding and swallowing disorders. It is the goal of the conference to present the latest in evaluation and remediation strategies for patients with swallowing disorders based on recent literature as well as emergent and successful clinical practices.

The morning will consist of a focused lecture format devoted to complex medical and management issues affecting individuals with feeding and swallowing impairments. In the afternoon, each participant chooses either the pediatric or adult clinical track, during which challenging case studies and age-specific diagnostic and management issues will be shared. The focus will be to enhance differential diagnostic skills, gain knowledge of new treatment modalities, and expand the participant's ability to develop individualized treatment plans to achieve positive outcomes.

TARGET AUDIENCE

The seminar is designed for medical and allied health practitioners who manage children and/or adults who demonstrate feeding and swallowing impairments.

STATEMENT OF NEED

Practitioners often approach the management of individuals with feeding and swallowing impairments within their own specialization, at times with limited success. A multidisciplinary group of physicians, swallowing specialists and allied health professionals will discuss the integration of medical, diagnostic and management options when providing clinical care across the age-spectrum. By integrating this new information, the clinician's ability to provide efficacious, evidenced-based treatment will be enhanced, resulting in targeted care and significant increases in function.

EDUCATIONAL OBJECTIVES

- Obtain positive outcomes by incorporating a collaborative model between swallowing clinicians and medical specialists to achieve best practices.
- Apply the latest research findings in the selection of appropriate instrumental testing and treatment procedures to improve your clinical care.
- Evaluate the impact of aspiration and aerodigestive disorders on pulmonary infections, malnutrition, dehydration and failure to thrive.
- Integrate nutrition principles across the lifespan when treating the feeding and swallowing disordered patient.
- Determine the least restrictive diet and optimize quality of life in the patient with advanced disease.
- Critically analyze published data on new treatment modalities to assess their value for your practice.
- Improve decision making and problem solving skills through discussion of pediatric and adult case studies.
