Housing Information:

On-Campus Housing

Housing is available for single law students in Dannat Hall, the University's residence hall located on the White Plains Campus. Dannat Hall is located within walking distance of all other facilities, including the law library, classrooms and the dining hall.

A typical room measures 16X20 feet. All rooms are furnished with a full-size bed, large desk with storage space and a high-back chair, two closets, mobile night stand, chest of drawers and a small table and chairs. In addition, all rooms contain a phone system with voice-mail and basic phone service for local calls and wiring that allows students to connect their PC's to the law school e-mail and Internet system.

All residents share common single-sex bathrooms per hall. Dannat Hall is a five story building equipped with a large recreation room that contains a big screen TV, pool table and study tables, a central kitchen, laundry facilities and a weight room.

Housing charges include cable television, Internet access, basic telephone and voice mail.

All admitted students interested in living on-campus must complete a housing application, which will be sent separately.

Off-Campus Living

For those students interested in living off-campus, we provide an "Off-Campus Housing List" which contains listings from the community and our own students, as well as links to local newspapers such as the Pennysaver, that contain housing listings and Realtor contacts. In addition, the Office of Admissions organizes and distributes a roommate referral list, and area maps to incoming students.

A variety of housing options are available within close proximity of the campus. Rates for residential housing vary widely. The following are some estimates of the cost of renting per month in the White Plains area: Studio Apts. \$900+, One Bedroom Apts. \$1000+, Two or More Bedroom Apts. \$1200+. Please note that living with other students provides moral support, study partners and reduces the cost of living. While some assistance is provided in locating off-campus housing, the final responsibility in securing housing rests with the student.
