**DISTANCE EDUCATION Reading Certificate Program**

The distance education Reading Certificate program at SDSU includes four online-only courses, scheduled during two consecutive summer semesters. These courses are offered through the College of Extended Studies, and credit for these courses may be applied to SDSU's MA in Reading Education and/or Reading Specialist Credential programs. The program requires students to participate in synchronous, time certain Blackboard-based live classroom sessions as listed in the class schedule. Students must have access to a computer with Internet connection (dial-up connection not recommended), speakers, and a microphone. Students are also required to have access to a video camera and video sharing software (Flip camera and FlipShare channel recommended).

Application to this program is a 2-step process (GRE scores are not required). The deadline for applying to CSUMentor is March 1, 2013 with completed applications to CSUMentor due by April 1, 2013.

**Step One**      Apply to the University at <http://www.csumentor.edu>. The Reading Certificate program can be found at CSUMentor listed as a type of credential. Submit both your application and the fee online, choosing the **DE Reading Certificate program**. Submit two sets of official transcripts to:
