SEMOSCA Membership definitions:

**Professional Membership** – to be eligible for professional membership, an individual shall:

1. Be engaged in school guidance work or in the training, preparation. Or supervision of counselors and have at least 50 percent of his/her time devoted to these activities.
2. Be fully certified as a professional school counselor by the Missouri DESE as having attained the specific requirements for the guidance position they hold.

**Regular Membership** – To be eligible for regular membership, an individual shall:

1. Be engaged in school guidance work or in the training, preparation. Or supervision of counselors and have at least 50 percent of his/her time devoted to these activities OR
2. Be fully certified by the Missouri DESE, but not currently employed as a school counselor.

**Student Membership** – Students who are in training and preparation for guidance work, but not currently employed as a professional

school counselor, shall be eligible for student membership upon presenting a statement from their major advisor. Student members shall be entitled to a 50 percent reduction in dues.

**Emeritus Membership** – To be eligible for emeritus membership, an individual shall:

1. Have held membership in the Association for 10 years.
2. Be retired
3. Make application annually

**Affiliate Membership** – any person interest in counseling, but not eligible for any other type of membership may become an affiliate member upon approval of the Governing Board.

**Sustaining Membership** - Any organization desiring to contribute to the support of the activities of the Association may seek an annual sustaining membership upon payment of the prescribed fee, and approval of the Governing Board.
