This 6 hour seminar brings together a wide range of professionals to provide Social Workers and other human service professionals with an overview of the juvenile court system and courtroom procedures. The format will include a mock trial, small group discussion and role-play.

The audience will:

- Become acquainted with the system players and their roles.
- Witness a mock trial and learn the difference between a juvenile adjudication and a termination of parental rights hearing.
- Learn the roles of social workers in the court system.
- Obtain information on reporting, investigating and preparing for filing the cases for juvenile court.
- Gain an understanding of pre-testimony preparation, pre-testimony anxiety and preparing witnesses for court.
- Examine the tactics and skills lawyers use to bring out the most effective testimony in any given case.
- Role-play being examined by the attorneys as if they were about to be called to the witness stand.
- Participate in small group discussion to process what it was like to "testify" and be examined by the attorney.
