Dear Customer:

As a convenience to you, CIBT can process International Driving Permits and Inter-American Driving Permits. These permits are accepted in many countries where a U.S. driver's license is not valid. They allow you to avoid problems with driving and renting cars in over 160 countries!

In order for CIBT to process your Driving Permit, you will need to send us the following:

APPLICATION FORMS: Provide 1 fully completed and signed copy of the attached application form. **This application form is two sided. It must be photocopied onto a single sheet of paper, front and back.**

OTHER MATERIALS: Please provide a copy of your valid driver's license from any U.S. State.

PHOTOGRAPHS: 2 passport size and quality photographs (2"x2") are required. **The photos must be signed on the reverse side.** Photos may be black and white or color, but should have a white background.

The expected processing time for this request is 3 business days; each permit is \$45.00 plus \$15 issuance fee and shipping fee of \$21. Please note all processing times, fees and requirements are subject to change without notice. If we are also processing a visa or passport for you then the Driving Permit will be completed at the same time.
