USCIS REGULATIONS ON FINANCIAL CAPABILITY

ADDITIONAL \$7,500 for a spouse, and \$3,000 for each child must be shown or guaranteed.**

It is the STUDENT'S responsibility to present acceptable evidence of adequate financial support BEFORE requesting the I-20 "Certificate of Eligibility" required for the student visa. Documentary proof of this support must be presented to the U.S. Consulate overseas when applying for the entry visa. USCIS officers at the U.S. port-of-entry may request it. ISSP may require additional documentary evidence.
