Please note that nominations for the Board of Directors, CSUEB Foundation, do not require five signatures. A separate section on the attached form is included for these nominations. Faculty Board members cannot be employed or receive assigned time from a grant or contract within the Foundation or have a real or perceived conflict of interest.

Only regular members of the University Faculty may be elected. Please refer to the January 8th memorandum for more detailed information regarding specific eligibility, or call Susan Correia in the Senate Office, extension 5-3671. The remaining positions on the Academic Senate and representation on Standing Committees will be handled through College, Library, Emeriti, Student Services and Lecturer Spring elections after the announcement of the at-large election results.
