1. **Contract Term:** Housing Services contracts with University Auxiliary Services, Inc. to provide meals for contracted residents. Selection of a meal plan on the Student License Agreement serves as an agreement to participate in the meal plan program. The contract term for occupancy serves as the same contract term for meal plans. By signing this agreement, you agree to participate in the meal plan program for the 2012-2013 Academic Year beginning, September 20, 2012 and ending June 14, 2013, and as such are financially responsible.
 - a. **Fall 2012** - The meal plan will begin on Thursday, September 20, 2012 through Friday, December 7, 2012. No meals will be provided on November 12, 2012 (Veteran's Day), November 22 - November 25, 2012 (Thanksgiving holidays), and during quarter break December 8, 2012 through January 6, 2013.
 - b. **Winter 2013** - The meal plan will begin on Monday, January 7 through Friday, March 22, 2013. No meals will be provided on January 21, 2013 (Martin Luther King Jr. Day) and during quarter break March 23 - March 31, 2013.
 - c. **Spring 2013** - The meal plan will begin on Tuesday, April 2, 2013 through Friday, June 14, 2013. No meals will be provided on May 27, 2013 (Memorial Day).
2. The dining area hours of operation are:
 - a. Lunch at the Distribution Center across from the University Club - Monday through Thursday 11:00 am to 3:00 pm and Friday 11:00 am to 2:00 pm.
 - b. Dinner in the Housing Dining Room - Monday through Friday 5:00 pm to 7:00 pm.
 - c. Brunch in the Housing Dining Room - Saturday and Sunday 11:00 am to 1:00 pm.
 - d. No meals will be provided outside of these operating hours.
3. Non-use of the meal plan does not constitute a cancellation of the program. Meal plans are not transferrable and missed meals will not carry over to the following week.
4. Cancellation policies follow the same terms and conditions as outlined in Section III. C. of the Housing Services License Agreement - Terms & Conditions.
