- ▶ To avoid delay, a final, itemized receipt from the "Make a Splash" program must be attached to this rebate application. This program ends on August 26, 2013. All applications must be received within 60 days of purchase.
- Water heating equipment must be fueled by natural gas.

Incomplete applications will be delayed. Minnesota Energy Resources reserves the right to verify sales receipts and installations. After approval, please allow four to six weeks for delivery of the rebate check.
