1. Scope of Supplies/Services/Works:

The scope of this call is to supply, install, maintain and dismantle temporary gazebo structures at the Valletta Bus Terminus (St James Ditch)

2. Procedure:

This Request for Quotations is being issued in line with the Public Procurement Regulations 2010 (Legal Notice 296 of 2010).

This Quotation is being issued as an OPEN procedure and will be also regulated by the Procurement General Conditions which are available on the DOC website https://secure2.gov.mt/EPROCUREMENT/conditions.

Transport Malta shall determine the award of the request for quotation on the basis of the <u>lowest price</u> compliant with specifications.

4. Information about the Tenderer's Technical Capacity:

The contractor shall provide for the necessary expertise and resources to ensure the delivery of the objectives. It is expected that the contractor is suitably experienced and equipped with qualified personnel who will be required during the project. Submitted experience on other similar projects will be considered an asset.

5. Evaluation and Award Criteria:

The award of services is to be made on the basis of lowest technically compliant financial offer

(Price) as shown in the attached Financial Submission Form and Financial Bid.

- Before submitting their Quotation, Bidders will be deemed to have satisfied all
 criteria, as to its correctness and completeness, to have taken account of all that is
 required for the full and proper performance of the contract and to have included all
 charges in their rates and prices.
- In submitting its Quotation, the Bidder will be submitting its best and final offer.

7. General Conditions:

7. Commencement & Execution

The execution of the contract for these works, at Valletta Bus Terminus is expected to start within one week from Instruction to start works and all works are to be completed within 1 week from same instruction as guided by the engineer / supervisor in charge.

Minimum hire is 6 months, should the six month time frame be exceeded pro-rata rate shall be applied.

8. Clarifications

Bidders are urged to promptly notify Transport Malta of any ambiguity in/or discrepancy between any of the appendices in this quotation which may be discovered upon examination of this document.

Any clarifications may be sent to tenders.tm@transport.gov.mt until 1600hrs on the 29th September, 2015. Response will be sent to all bidders until 1600hrs on the 30th September, 2015.

Bidders are notified that any interpretations, corrections or changes to the RFQ will be notified via the Transport Malta website http://www.transport.gov.mt/organisation/procurement . It is the responsibility of Bidders to visit this website and be aware of the latest information published on the Transport Malta.

9. Validity of Quotation

Bidders are committed to retain the validity of the Quotation for a period of sixty (60) days from the closing date for the submission of the quotation as shown in 3 above.

10. Evaluation of Quotations

a) The entire evaluation procedure is confidential. The Evaluation Committee's decisions are collective and its deliberations are held in closed session. The members of the Evaluation Committee are bound to secrecy.

- b) The Evaluation Committee ranks the bids based on lowest cost.
- c) In the interest of transparency and equal treatment and without being able to modify the submitted Quotation, the Bidder may be required, at the sole written request of Transport Malta, to provide clarifications.
- d) Transport Malta reserves the right to conduct an interview with the Bidder to assess the Bidder's experience and approach to the delivery of the requirements.
- e) The Committee will recommend to award the quote to the lowest compliant bid received.
