Your Responsibilities as a Grower:

- Although PGF will routinely check the operation of your chamber there is **NO GUARANTEE** that the chamber will operate properly. We cannot be responsible for fire, chemical spills, temperature/humidity/light faults, or power outages. Notify PGF (Jennifer or Lucas) if you notice malfunctions.
- Keep personal area in, on, and around chamber clean. No storing of materials (except watering can) in, on, or around chamber.
- Watering is your responsibility – Please do not heavily water, water will spill onto controls below the chamber. However, the lights within the chambers have been known to dry out plants much faster than normal light!
- Check routinely for the presence of insect pests and diseases. It is your responsibility to report outbreaks to PGF. If you want to personally apply pesticides, this must be discussed with PGF before any application can be made.
- Sanitary cultivation is required.
- Trashcans are provided for your convenience. Please empty trashcans into the dumpster/compost bin if you contribute significantly to them, or if they are full
- Leave growth chamber as you found it upon completion of your project (completely free of everything you put in). PGF will loan cleaning supplies if you desire. PGF will charge a \$25 cleaning fee if more than normal sanitation is needed at the end of your term.
- Do not adjust environmental controls! If adjustment is needed, contact PGF
