### Photo/Videotape Release

I give permission for my child to be photographed, interviewed, or videotaped for stories/articles promoting our school or the school system (PCSD). These stories may appear in newspapers or on television. I consent for the release of the photograph/videotape to the media in school-related coverage.

### Web Page Release

I give permission for photographs, exemplary classroom projects/events, or descriptions of extracurricular activities involving my student to be posted on the school system's web page which can be addressed on the Internet at <http://www.paulding.k12.ga.us>. In posting a photograph, exemplary classroom projects/events, or extracurricular activities of a student, the PCSD is careful not to associate a student's full name in such a way that it can be identified with a photograph of a student.

### Emergency Release Information/Permission

At times, it is necessary for the school to close early because of weather, loss of heat or water, or other unexpected happenings. For this reason, it is important for you to discuss with your child what to do if students are released early. In order to keep the phone lines free on occasions when school closes early, we need to know in advance how to send your child home from school. I intend for my child to leave school by bus or car rider as normal during emergency situations. *If I do not intend for my child to leave school during emergency situations in this manner, I will check "no" below and provide further instructions.*

### Field Trip Permission/Release

I give my permission for my son/daughter to participate in field trips during school hours when accompanied by instructional staff. Parents will be notified in writing prior to any off-campus field trip.

### Surveys Release

In order for state and local agencies and the school system to evaluate programs and activities, surveys/needs assessments are conducted. The Georgia Department of Education uses a state-wide "Student Health Survey," which is administered to students in grades 6, 8, 10, and 12. In addition, a Safe and Drug Free School Survey is conducted with students in grades 7-12. Permission must be received from the parents/guardians of students in order to collect information typically related to drug use, violence, attitudes and/or behaviors. You may examine the surveys at the Central Office. The questionnaires are totally anonymous. I consent for my child to participate in any of the surveys/needs assessments described above.

### Internet Use Permission

The PCSD maintains an electronic communication network that includes Internet access. Access to the electronic communication network, as well as the hardware and software that support access shall be used solely in support of the educational objectives of the school system. Use of this property is a privilege that may be discontinued at any time. Students who do not follow the rules and guidelines for the acceptable use of the Internet (listed in the student information guide) and its related hardware and software will be subject to disciplinary action. I give my child permission to use the Internet as part of his/her instructional activities while attending school.

### Received Student Information Guide

At the time of registration, both my student and I received a copy of the Student Information Guide. The Student Information Guide contains the dress code, attendance policy, and discipline code for the PCSD. We understand that my student is to adhere to the policies contained therein.
