### **Outline Example – Creative and Original Title**

I. The first section of your outline should summarize the information that you will include on the **Introduction Page** of your third world country website.

A. The detail sentences in your outline should answer the questions asked in this section.

1. I have chosen to investigate the impact of (chosen social justice issue) on the country of (chosen third world nation).

2. The population of this country suffers from these other primary social justice issues...

B. Include your third world county thesis statement.

1. Remember, every “A” in an outline requires a “B”.

2. Every “1” in an outline requires a “2”; if you do not have enough detail for at least 2 bullets, then include all of your information on the previous level.

3. I have found an appropriate digital image for the Introduction section of my website at this URL: <http://www.appropriatedigitalimage.org>. Remember to use the short URL from the primary source of the image, not the search engine URL.

II. The second section of your outline should summarize the information that you will include on the **Country Page** of your third world country project.

A. The detail sentences in your outline should answer the questions asked in this section.

1. I will include a map which I found at this website: \_\_\_\_\_ to show the location of the country which I have chosen.

2. This third world country borders: \_\_\_\_\_ and \_\_\_\_\_.

E. – J. Continue to answer all of the questions, using as many detail sentences as needed to provide a complete and thorough outline.

III. The third section of your outline should summarize the information that you will include on the **Impact Page** of your third world country project.

A. The local programs which I have discovered which have an impact on the social justice issue in this country.... Remember, local in this context means **in** your country, **not** here in Dallas.

1. Detail the local programs such as local hospitals or government agencies which have attempted to address the needs of the population impacted by the social justice issue(s) which you have chosen to investigate.
2. Make sure to summarize the successes and short-comings of these local programs and discuss key individuals who have worked locally to make a difference.

B. The global community has helped to impact the social justice issues in this third world country by/through...Remember, in this context, global refers to countries and organizations **not in** the United States.

C. The United States or US Aid Organizations currently help this country through...Here include all organizations which have their headquarters in the United States, even if they focus their efforts internationally.

D. I have discovered that \_\_\_\_ legislation has had a positive/negative impact on the population of this country because...Remember, legislation refers to laws either locally or internationally such as humanitarian restrictions, curfews, treaties, embargoes, tariffs, maritime restrictions, UN policies, etc.

1. Again answer every question in this section in outline form.
2. Use complete sentences and indicate which digital images you will incorporate.
3. Make sure that you keep track of the sources of the information and images that you include, as you will need to include all of these sources in your annotated bibliography.

E. – I. Continue to answer all of the questions, using as many detailed sentences as needed to provide a complete and thorough outline.

IV. The final section of your outline should summarize the information that you will include on the **Conclusion Page** of your third world country project.

A. The detail sentences in your outline should answer the questions asked in this section.

on your findings. Remember, your conclusions summarize 8 months worth of research!
