The IRS sets annual contribution limits each year for individuals with single and family high-deductible health plan (HDHP) coverage. This statutory maximum is subject to annual cost-of-living adjustments. Definitions for HDHP coverage and annual contribution limits can be found at http://www.irs.gov/pub/irs-pdf/p969.pdf. Account owners who have attained age 55 may be eligible for an increased contribution limit of \$1,000.

Contributions may be made up through April 15 of the following year.

If your employer is making contributions to your account, you must take those amounts into consideration when you calculate any contributions you may make to your HSA.

All deposits may be subject to a four business day clearing period.
