A NON-MEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT OR TRAINER AT REGULAR MEMBER COMPETITIONS, EVENTING COMPETITIONS, DRESSAGE COMPETITIONS AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$20.00 NON-MEMBER REGISTRATION FEE AND A \$5 BREED/DISCIPLINE CATEGORY FEE FOR EACH BREED/DISCIPLINE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPTED FROM THE REQUIREMENTS OF THE RULE: 1) LEAD LINE; 2) EXHIBITIONS; 3) GAMES AND RACES; 4) CLASSES FOR 4-H MEMBERS; 5) WALK TROT AND ACADEMY CLASSES (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES. ALSO EXEMPTED FROM THIS REQUIREMENT ARE RESIDENTS OF OTHER NATIONS WHO ARE MEMBERS IN GOOD STANDING OF THEIR NATIONAL FEDERATIONS AND. 7) ASSISTANT HANDLERS IN DRESSAGESPORT HORSE BREEDING CLASSES; AND 8) CITIZENS OF OTHER NATION WHO ARE MEMBERS IN GOOD STANDING OF THEIR NATIONAL FEDERATIONS AND, IN THE CASE OF RIDERS, DRIVERS, OR VAULTERS COMPETING IN DISCIPLINES RECOGNIZED BY THE FEI, IN POSSESSION OF A

## US Equestrian Entry Agreement

By entering an US Equestrian-recognized Competition and signing this entry blank as Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter, or Longeur and on the behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Constitution and Rules of the US Equestrian ("the Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the competition may use or assign photographs, videos, audios, cablecasts, or likenesses of me and my horse, taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation Rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State

## USEquestrian Release, Assumption of Risk, Waiver and Indemnification.

This document waives important legal rights. Read carefully before signing.

I AGREE in consideration for my participation in this Competition to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Federation Rules about protective equipment, including Articles 318 and 1712, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and agree to assume all of the obligations of this Release on the child's behalf.

I AGREE the "the Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, and affiliated organization.
