Will we go to sleep with noise (music or TV) and/or lights on? What should we do if one of us snores? What should we do if the phone rings or someone stops by when one of us is sleeping? What time will we wake up? How many times can we hit the snooze button? If one of us comes in late, what should we do about turning on lights, getting ready for bed, etc.? In what order are the priorities of sleeping, studying, and socializing for this room?

<p>CLEANING THE ROOM:</p> <ul style="list-style-type: none"> • Who will clean which parts of the room? • How often will we clean? • Neat or messy room? 	
<p>COMMUNICATION:</p> <ul style="list-style-type: none"> • Where will we leave messages for each other (phone, visitors, etc.)? • How should we communicate with each other (notes, face-to-face, Facebook)? • Can we be open and honest with each other? • What should we do if we have a problem with each other? • Privacy when we're on the phone? 	
<p>ROOM SECURITY:</p> <ul style="list-style-type: none"> • When will we lock the room door? • Friends in the room when we're not here? 	
<p>PET PEEVES:</p> <ul style="list-style-type: none"> • It really bothers me when.....
