

## 2013-2014 Special Circumstance Appeal Form Office of Financial Aid Saint Xavier University

This Special Circumstance Appeal Form can be used by you and your family to report unusual circumstances that may impact your ability to pay for your education at Saint Xavier University. These circumstances can be conditions that have reduced your income for 2013 or extraordinary expenses that provide you with less disposable income.

Before the Office of Financial Aid can review the information on this form, you must have previously filed a 2013-2014 Free Application for Federal Student Aid (FAFSA).

To be reviewed, this form must be completed in its entirety. All appeals require the following:

## **REASONS FOR APPEALS**

Please check the box(es) that best describe your special circumstance(s):

- Applies If: 2013 income for you and/or your parents will be considerably less than 2012 income.
- Examples Include: Loss of employment; reduction in wages; expiration of unemployment benefits; loss of untaxed income or benefits; loss of one-time income, such as inheritance, lottery, or IRA/pension/capital gains distributions.
- Documentation Needed: Most recent paycheck stub(s), unemployment benefits statement, and any additional documentation that verifies the loss of income.

#### Excessive Medical/Dental Expenses

- Applies If: Medical/Dental expenses exceed 7.5% of your Adjusted Gross Income (AGI).
- Documentation Needed: For 2012 expenses, provide your Federal Income Tax Return Schedule A (or copies of bills/insurance statements, if Schedule A was not filed). For 2013 expenses, provide bills demonstrating amount paid (not covered by insurance).

#### Elementary/Secondary Tuition for 2013-2014

- Applies If: Your parents will pay elementary or high school tuition for their other dependents for the 2013-2014 academic year.
- Documentation Needed: Attach a photocopy of the tuition statement from each school. If the 2013-2014 tuition statement is not yet available, please attach a photocopy of the 2012-2013 tuition statement with any expected tuition increase amount.

Separation, Divorce or Death of Parent

- Applies If: Since you filed your 2013-2014 FAFSA, your parents have been separated or divorced, or a parent died.
- Documentation Needed: Legal separation document (or signed and notarized statement from your parents, along with proof of separate residence), divorce decree, or copy of death certificate.
