**RESOLUTION IN SUPPORT OF KEEPING THE WINNEBAGO COUNTY

WHEREAS: The University of Wisconsin-Oshkosh has approximately 3,219 students living in residents halls on campus.

WHEREAS: The residents halls are open with residents living in them for approximately 9 months of the year.

WHEREAS: The current 16th County Board Supervisory district runs continuous with the 13th and 14th wards of the city of Oshkosh which includes all of the residence halls on the UW-Oshkosh campus.

WHEREAS: A reduction in the size of the Winnebago County Board will jeopardize the 16th supervisory district's continuous relationship with the UW-Oshkosh campus.

WHEREAS: The Oshkosh Students Association (OSA) recognizes the importance of students roles and involvement in both student and local government.

THEREFORE BE IT RESOLVED: That the Oshkosh Student Association (OSA) supports that the Winnebago County Board of Supervisors keep their current board size of 36 supervisors.

BE IT FURTHER RESOLVED: That the Oshkosh Student Association (OSA) calls upon the Winnebago County Board of Supervisors to maintain student representation on the county board by ensuring that the 16th district remains intact and continuous with the UW-Oshkosh campus.

WHEREAS: Governor Scott Walker introduced a “Budget Repair Bill” on Friday, February 11 to fix the current state budget deficit;

WHEREAS: Governor Walker’s “Budget Repair Bill” permanently removes all collective bargaining rights for University of Wisconsin System faculty and staff;

WHEREAS: Governor Walker’s “Budget Repair Bill” permanently removes nearly all collective bargaining rights, including the right to negotiate for safer working conditions, for most other public employees;

WHEREAS: the right to collectively bargain is provided to every private sector employee and is a United Nations recognized human right as stated in the Universal Declaration of Human Rights;

WHEREAS: the Governor’s “Budget Repair Bill” requires each public employee to pay 12% of their health care premiums and 6% of their pension contributions leading to an effective reduction in pay of more than 10% for some employees;

WHEREAS: University of Wisconsin System professors are already paid 10 - 20% less than professors at comparable non-Wisconsin universities according to the University of Wisconsin System’s *Competitive University Workforce Commission’s Final Report*, issued in June of 2010;

WHEREAS: the quality of a University of Wisconsin System education is dependent upon having fairly compensated and rewarded faculty and staff;

WHEREAS: all students enrolled at the University of Wisconsin Oshkosh are members of the Oshkosh Student Association (OSA);

THEREFORE BE IT RESOLVED: that the student body of the University of Wisconsin Oshkosh expects Governor Scott Walker and the State Legislature to respect the right of state employees to collectively bargain on the conditions of their employment;

FURTHER BE IT RESOLVED: that Governor Walker's "Budget Repair Bill" should be rejected in its current form;

FURTHER BE IT RESOLVED: that any replacement for the Governor's "Budget Repair Bill" should not infringe on public employee collective bargaining rights and any cuts to employee compensation should be done with appropriate consideration of the value of University of Wisconsin faculty and staff;

FURTHER BE IT RESOLVED: that the OSA fully supports the statements on the "budget repair bill" by the University of Wisconsin – Oshkosh Faculty Senate and Senate of Academic Staff issued 25 February 2011;

WHEREAS: Governor Scott Walker introduced the State Biennium Budget Bill on March 1, 2011;

WHEREAS: every state agency, legislature, employee, and citizen needs to find creative ways to reduce costs while ensuring high quality services to residents of the great state of Wisconsin;

WHEREAS: on July 9, 1974 the University of Wisconsin System was formally created, which brought together the public colleges and universities in the state of Wisconsin;

WHEREAS: the State Biennium Budget Bill includes giving the University of Wisconsin Madison public authority status;

WHEREAS: granting leadership flexibilities to an institution gives it the tools it needs to build a business model that enables it to react more efficiently and with greater effectiveness;

WHEREAS: for the last ten years the University of Wisconsin System and the Board of Regents have been advocating for the entire UW System to be granted leadership flexibilities;

WHEREAS: granting the entire University of Wisconsin System leadership flexibilities will keep the cost of attendance reasonable for students, while enhancing the quality of education because of the elimination of state restrictions;

THEREFORE BE IT RESOLVED: that the Oshkosh Student Association (OSA) supports that the entire University of Wisconsin System be granted leadership flexibilities as a measure to cut costs, increase efficiency, and educational quality and access;

FURTHER BE IT RESOLVED: that the OSA supports an amendment to the State Biennium Budget Bill that includes the provision of all UW System Institution's gaining leadership flexibilities;

FURTHER BE IT RESOLVED: that the OSA does not support granting public authority status to the University of Wisconsin Madison as it creates an unequal situation and takes away a large funding source from the rest of the University of Wisconsin System;

WHEREAS, The Oshkosh Student Association's central mission is to represent and further the interests of the University of Wisconsin-Oshkosh's student body, and;

WHEREAS, It is the firm belief of the Oshkosh Student Association that Senate Bill 6, commonly termed the Voter ID Bill, currently under debate in the Wisconsin State Legislature, is adverse to the student population, and;

WHEREAS, The Oshkosh Student Association recognizes the vital importance of voting in ensuring that the student voice is taken into account in government, and;

WHEREAS, The policies promulgated in Senate Bill 6 will substantially lower voter turnout on campus, specifically, with its provision disallowing the use of student identification cards, and;

WHEREAS, The students of the University of Wisconsin-Oshkosh rely on current law in order to exercise their voting rights, and;

WHEREAS, The requirement of presenting a valid Wisconsin driver's license, Wisconsin identification card, or current U.S. uniformed service identification card in order to vote at a polling place or obtain an absentee ballot will disproportionately affect the student vote, and;

WHEREAS, The Oshkosh Student Association would like to call attention to the critical fact that the first few years after becoming eligible to vote is the period when voting habits are formed, and;

WHEREAS, The proposed legislation which would necessitate obtaining a new form of identification following every change of residence, would be a considerable burden on students, who are the most nomadic segment of society, and;

WHEREAS, The Oshkosh Student Association opposes the addition of barriers to the voting process, and;

WHEREAS, The Oshkosh Student Association is proud of Wisconsin's progressive heritage,

THEREFORE, BE IT RESOLVED that The Oshkosh Student Association, on behalf of the University of Wisconsin-Oshkosh, formally calls upon the Wisconsin State

Assembly, the Wisconsin State Senate, and the Governor of Wisconsin to prevent the aforesaid proposed legislation from becoming law, and;

BE IT FURTHER RESOLVED that the President of the Oshkosh Student Association, Timothy Suess, forwards this resolution upon passion to Chancellors, Vice Chancellors, Governor Walker and State Legislators.
