

Requirements for application of the Thuthuka bursary

- The learner must be African or Coloured
- **@** The learner must be a South African Citizen
- The learner must obtain at least 60% on Mathematics (5 or above on the NSC Scale of Achievement) **NOT MATHS LITERACY**
- The learner must be in Grd12 intending on studying B comm. Accounting
- The learner must be financially needy and will be assessed using the NSFAS MEANS TEST to confirm financial need
- The learner must not be out of Matric/school for more than 2 years.

The Process of Awarding a Bursary

- The application must have met the above criteria
- The learner must have or be in the process of applying to one of the following tertiary institutions:
 - ➤ University of Johannesburg
 - ➤ University of Cape Town (Bachelor of Commerce code CB011)
 - > Nelson Mandela Metropolitan University
 - > Stellenbosch University
 - ➤ University of Pretoria
 - ➤ University of Orange Free State
 - ➤ University of Witwatersrand (WITS)
 - ➤ North-West University (Mafikeng Campus)
- Once the learner has met the above criteria they will be called in for testing
- Depending on the test results then the learner may be called in for an interview.

Once the learner has met all the above requirements and gone through the relevant test and interview only then will the bursary be provisionally awarded to the learner pending the final Grade 12 results.

The closing date for our bursary is the 30th of April 2014 for the following year.

- 5. When applying to UCT you must enroll for the **Bachelor of Commerce code CB011**
- 6. All applicants are required to write the National Benchmark Test (NBT) by June 30th 2014.
- 7. Your application will remain incomplete until we receive the letter of provisional acceptance to university, the final Grade 12 results and NBT results.

IMPORTANT INFORMATION TO BE NOTED BEFORE COMPLETING THE **APPLICATION FORM**

- 1. The Thuthuka bursaries are only available for African and Coloured learners.
- 2. Forms must be completed and returned to Thuthuka Bursary Fund, PO Box 59875, Kengray, 2100. (BEFORE 30 APRIL).
- 3. Only Students doing Mathematics as a subject will be considered. NOT MATHS LITERACY!
- 4. The value of the bursary is dependant on availability of funds at the time. You will be required to take out a NSFAS loan, arranged with our assistance, each year. Part of this loan is converted to a bursary if you pass each year.
- 5. Applicants provisionally awarded bursaries will be notified in December.
- 6. Confirmation of the awarding of the bursary will be made upon receipt of final Grade 12 results as well as entry into the Thuthuka programme at one of the Thuthuka universities.
