PRACTICAL THERAPEUTIC INTERVENTION FOR CHILDREN WITH MOTOR SPEECH DISORDERS

This full-day program will provide an overview of what to look for in children with motor speech issues.

Her areas of special interest include motor speech disorders, sensory integration disorders, early language development and PDD/ Autism Spectrum Disorders. Tracey is a Certified PROMPT Instructor and teaches workshops in various locations throughout the United States. She is also an adjunct instructor for the Division of Continuing Education and Professional Development at Molloy College.

Jennifer Shapiro, M.A. CCC-SLP, PROMPT Instructor, is an ASHA certified speech-language pathologist currently in private practice in Plainview, New York. She has clinical experience in various settings including the public school system and the New York State Early Intervention Program. SPEECH AND LANGUAGE EVALUATIONS AND ONGOING ASSESSMENT: QUANTIFYING SUBJECTIVE MEASURES

This program focuses on the use of free and low-cost technology to quantify subjective measures during speech-language evaluation and therapy. Participants will learn about and use widely available speech analysis programs and other software that will enhance their clinical assessments. An emphasis will be placed on using speech analysis software to demonstrate and support eligibility criteria at the initial evaluation level and to measure progress during ongoing assessment in therapy.

Participants will engage in hands-on training and practice of 1) converting and preparing media, such as clinical videos or audio files, for sound analysis, 2) objective analysis measures to supplement, confirm, or exclude subjective impressions, and 3) generating reports for supplementing clinical assessments and service recommendation reports.

This program is suitable for individuals with all levels of computer skill and working in a variety of clinical settings. Examples include schools, hospitals, private homes and rehabilitative centers.

It is strongly recommended that participants bring a personal laptop to this course in order to participate in hands-on training and practice. Instructions on downloading the free software necessary for course demonstration and participation will be provided prior to the course date.

About The Presenter

Janet Ann Lee, MA, CCC-SLP, TSHH is a certified speech-language pathologist with related certification in applied behavior analysis. She also is a trained vocologist, with certification from the National Center for Voice and Speech, as well as professional operatic training and experience in theatre, opera, television, film, and print media. Ms. Lee's areas of clinical specialization include fluency, language-based learning disorders, special education referral procedures, and habilitation of professional singing voice. Research areas of interest include spectral analysis of singing voice, neurophysiology of music cognition, and neural overlap of language and music.
