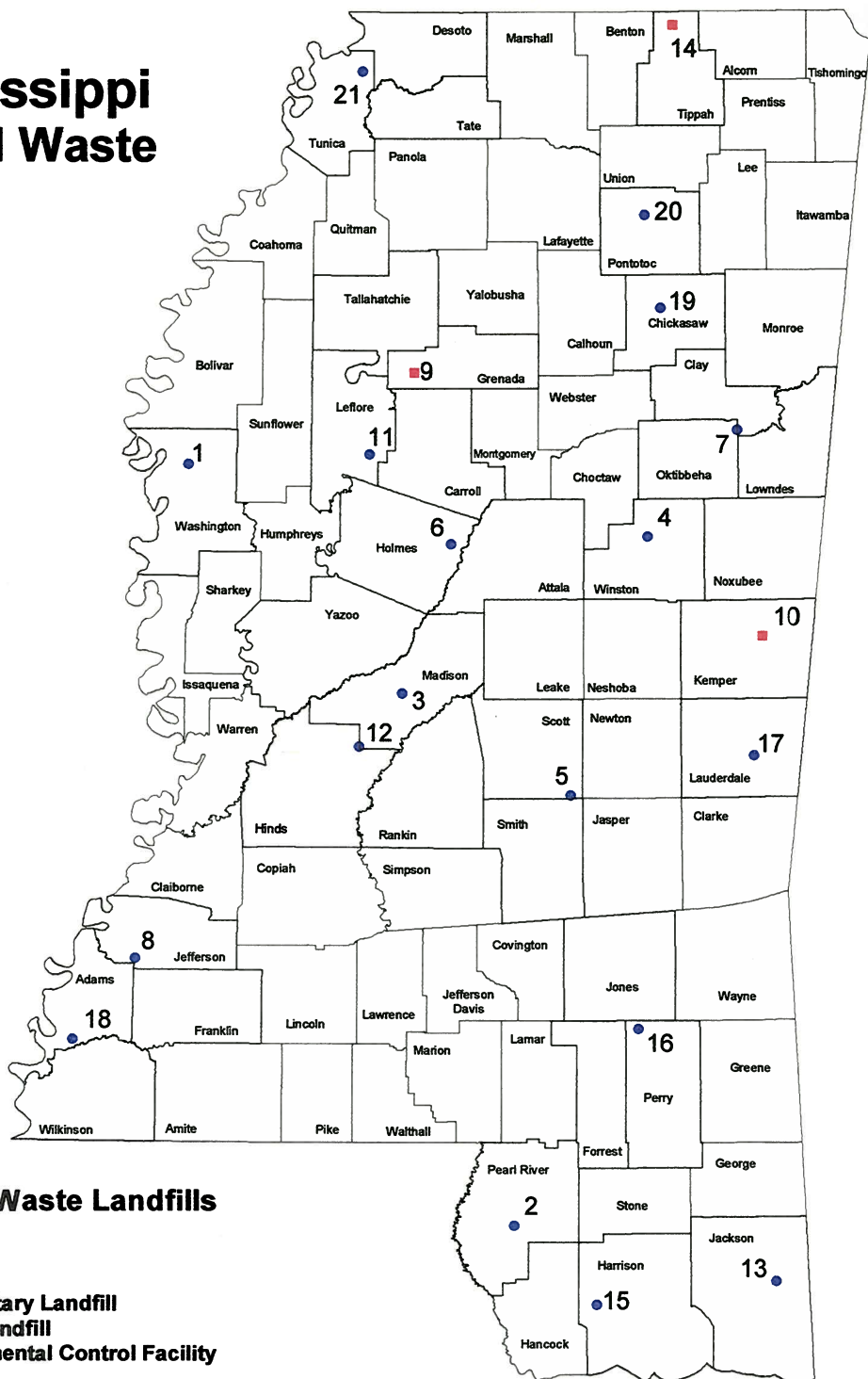

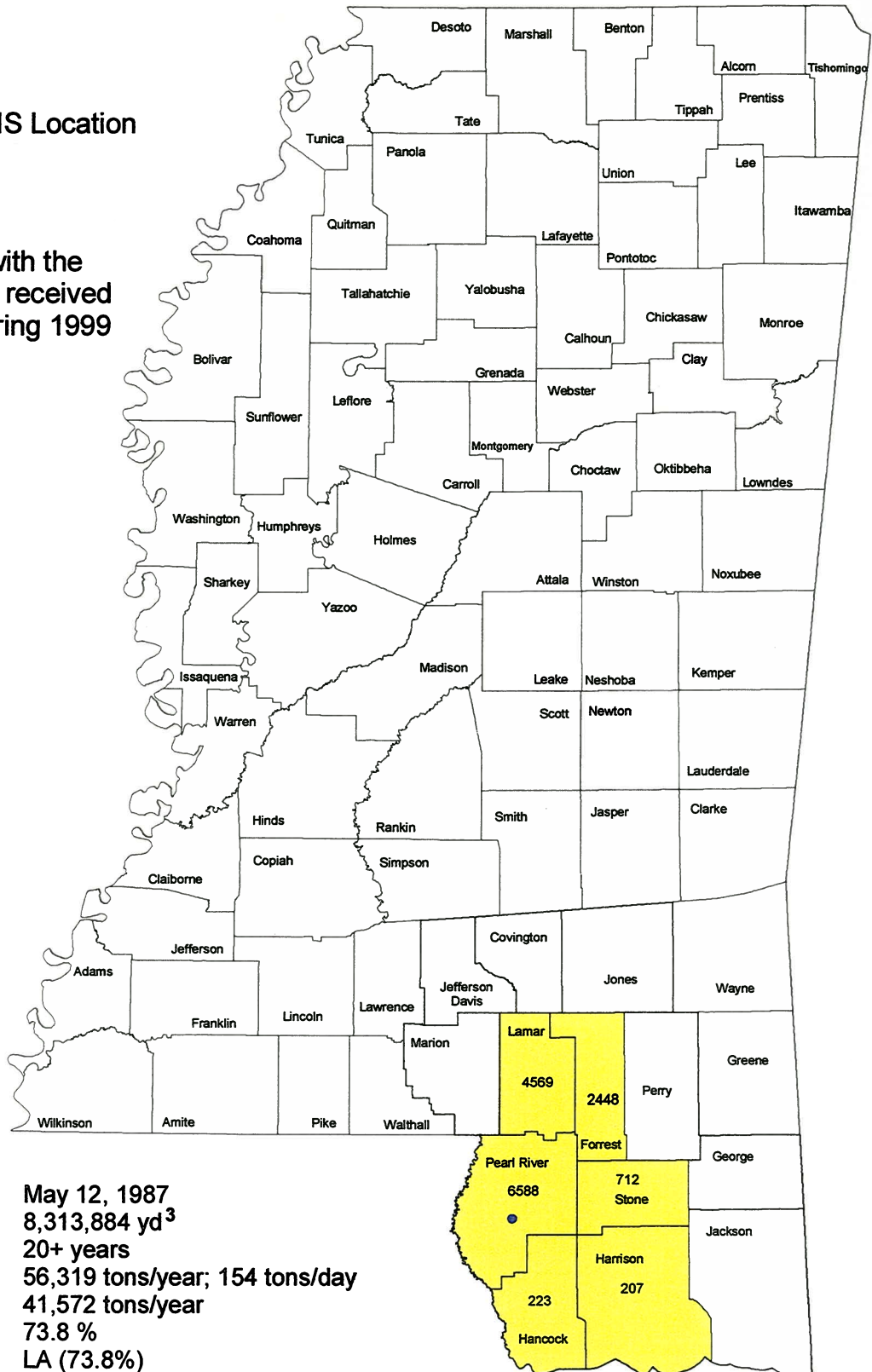

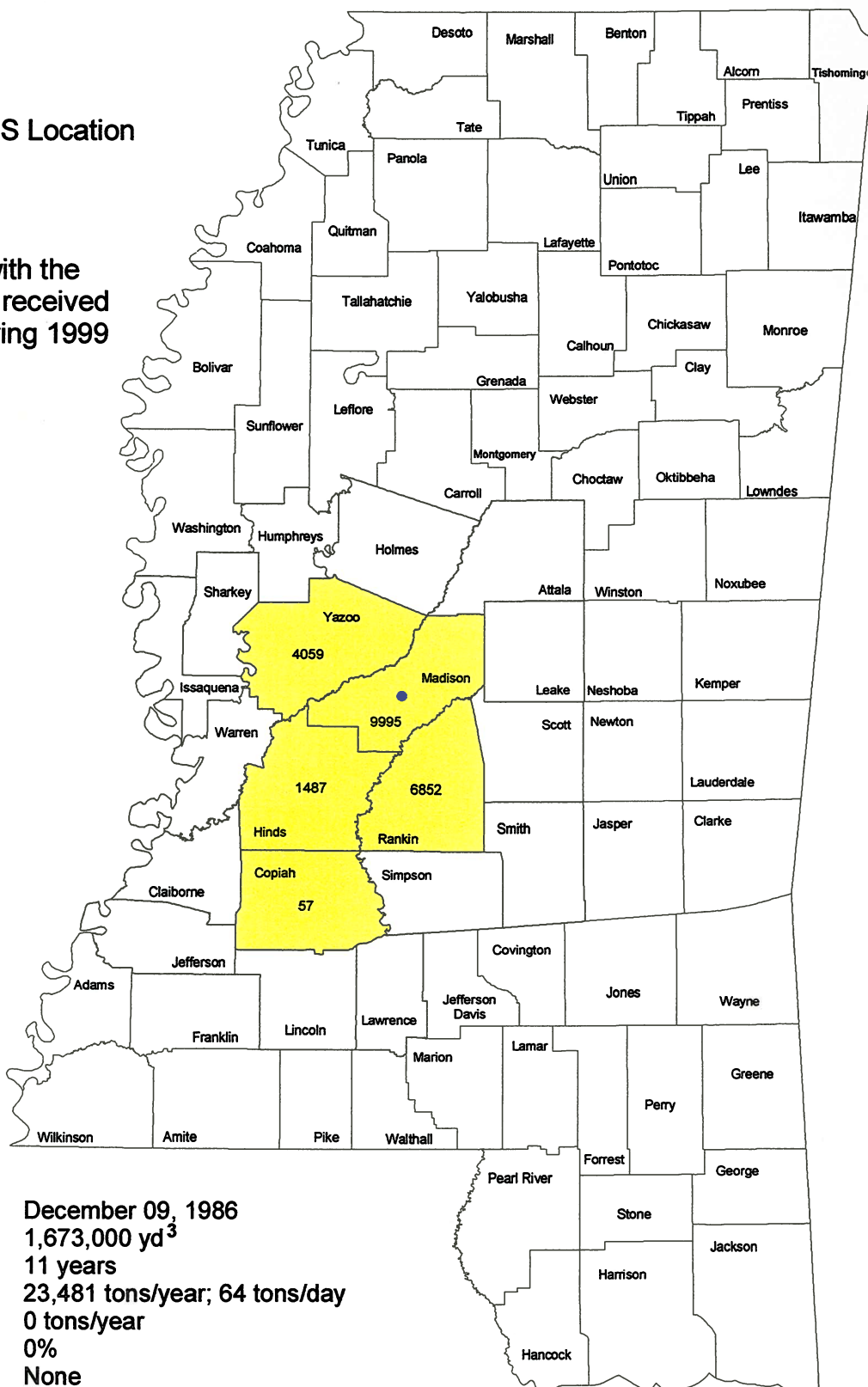

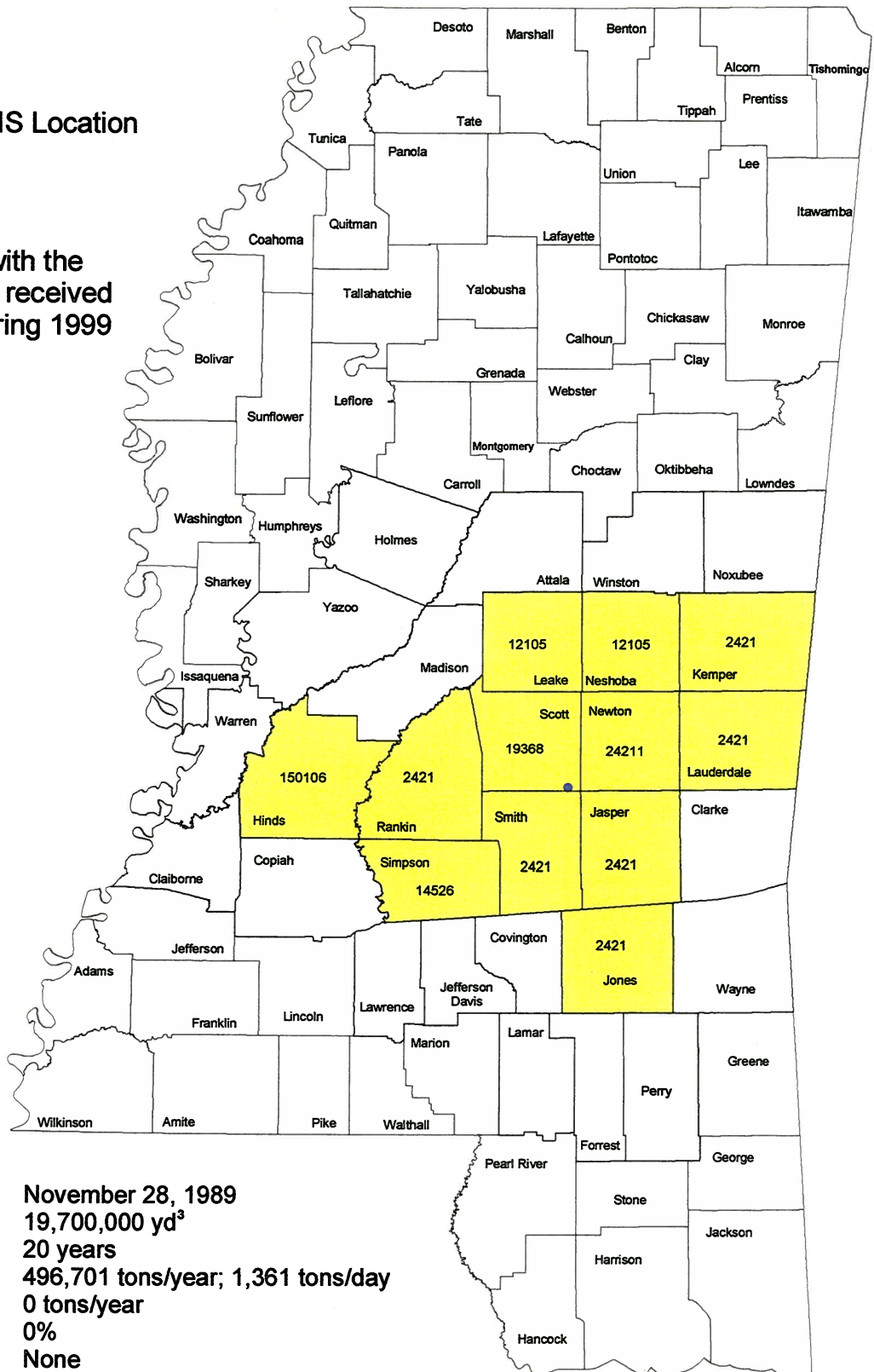

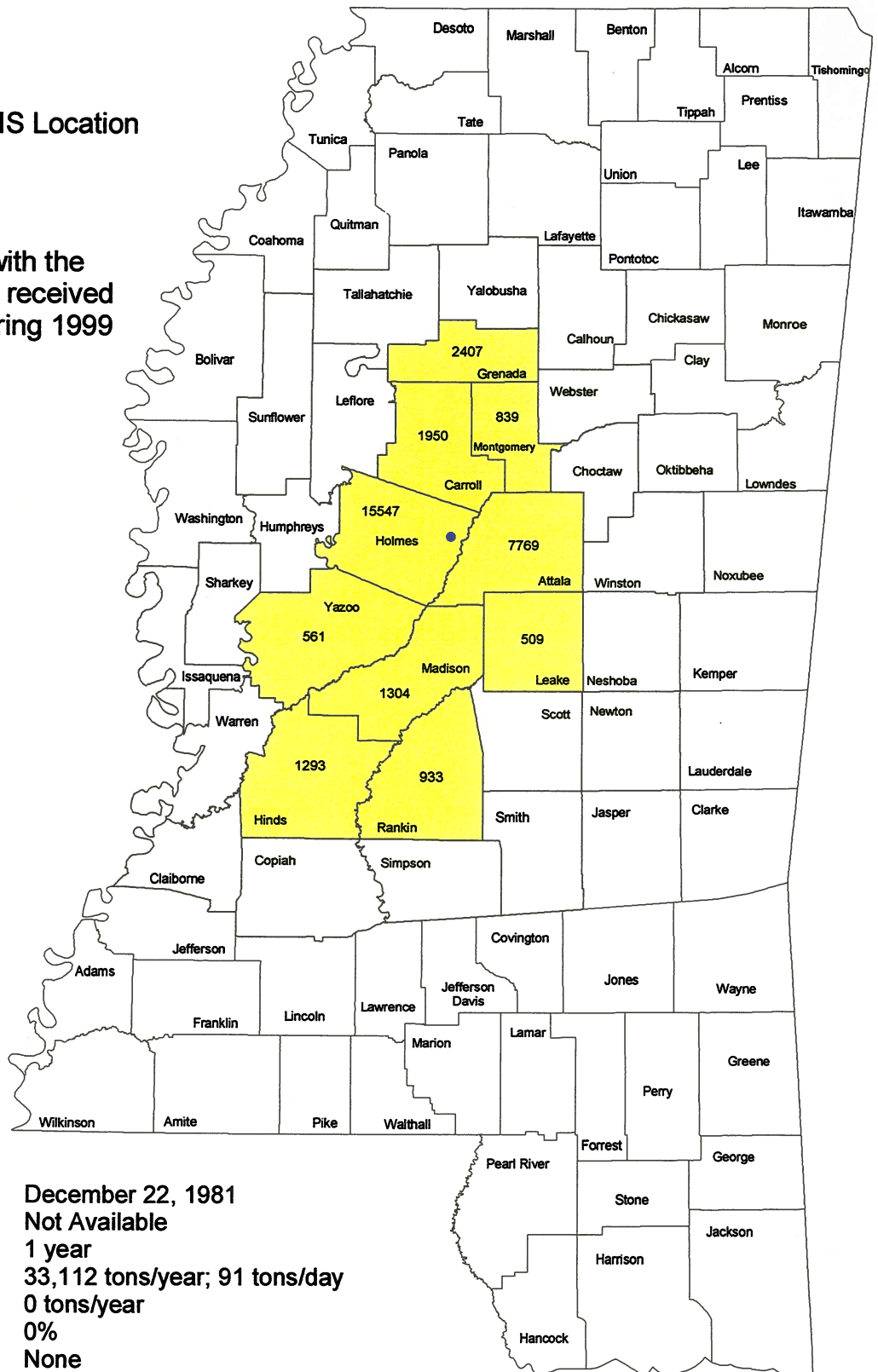

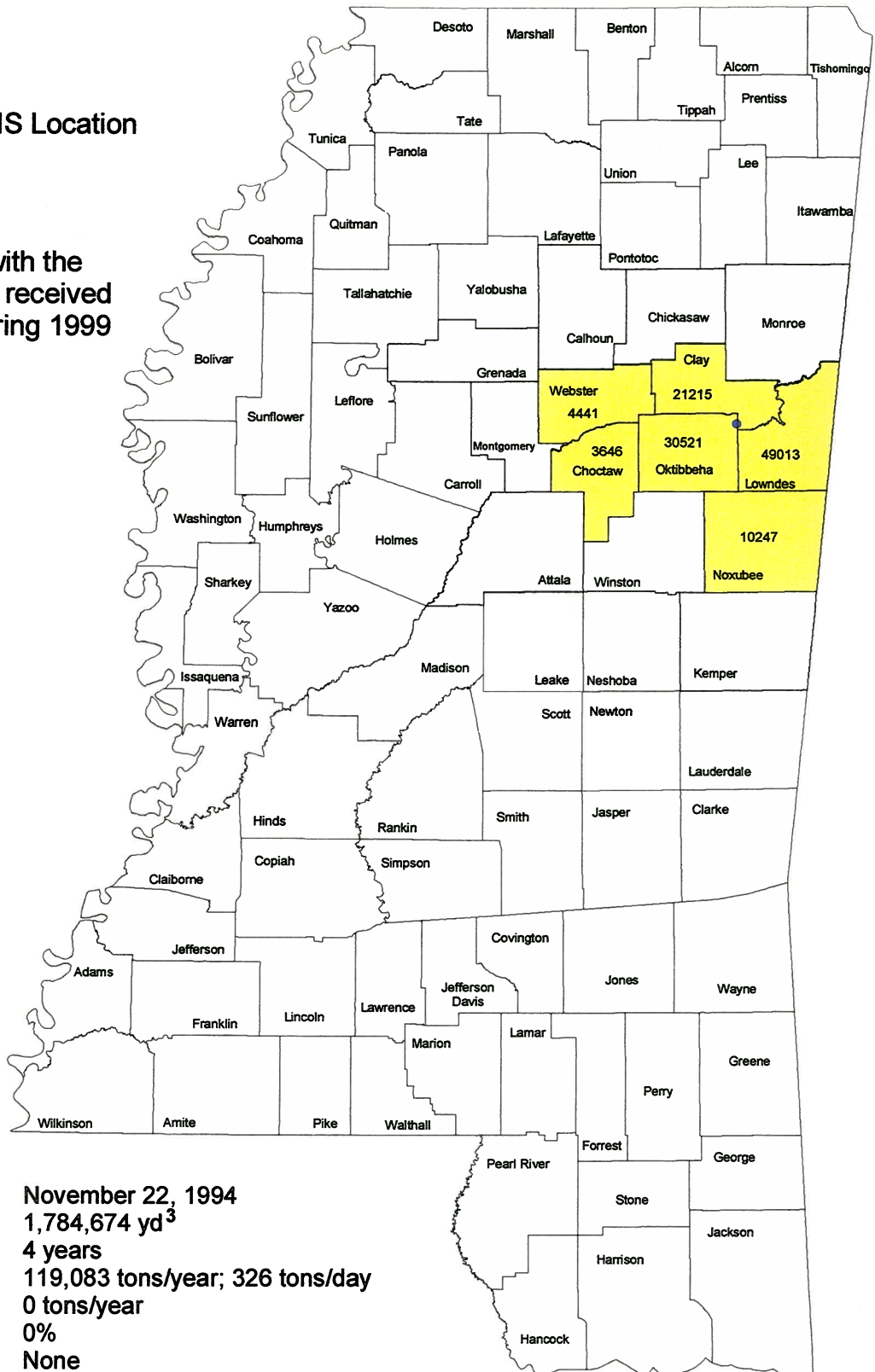

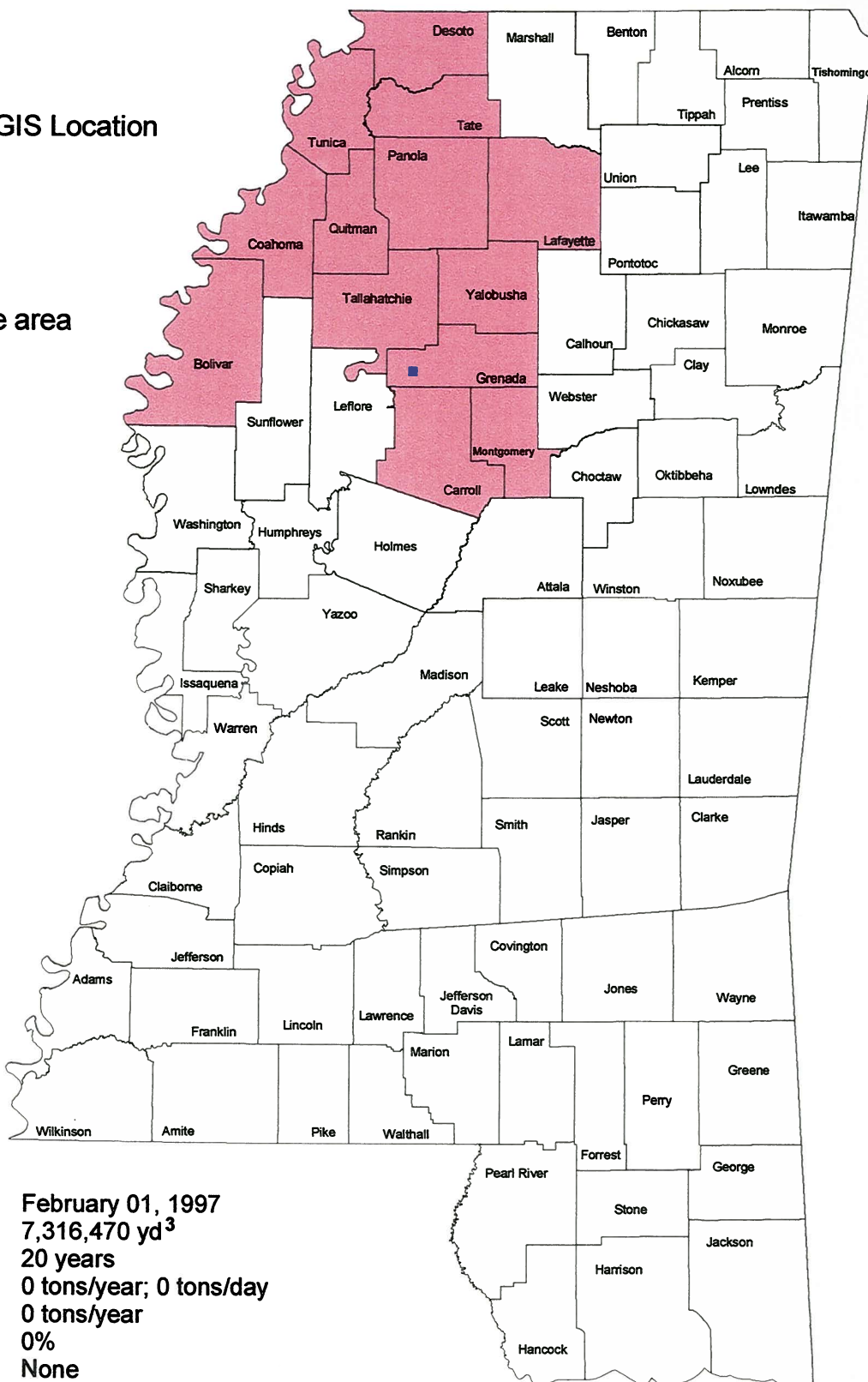

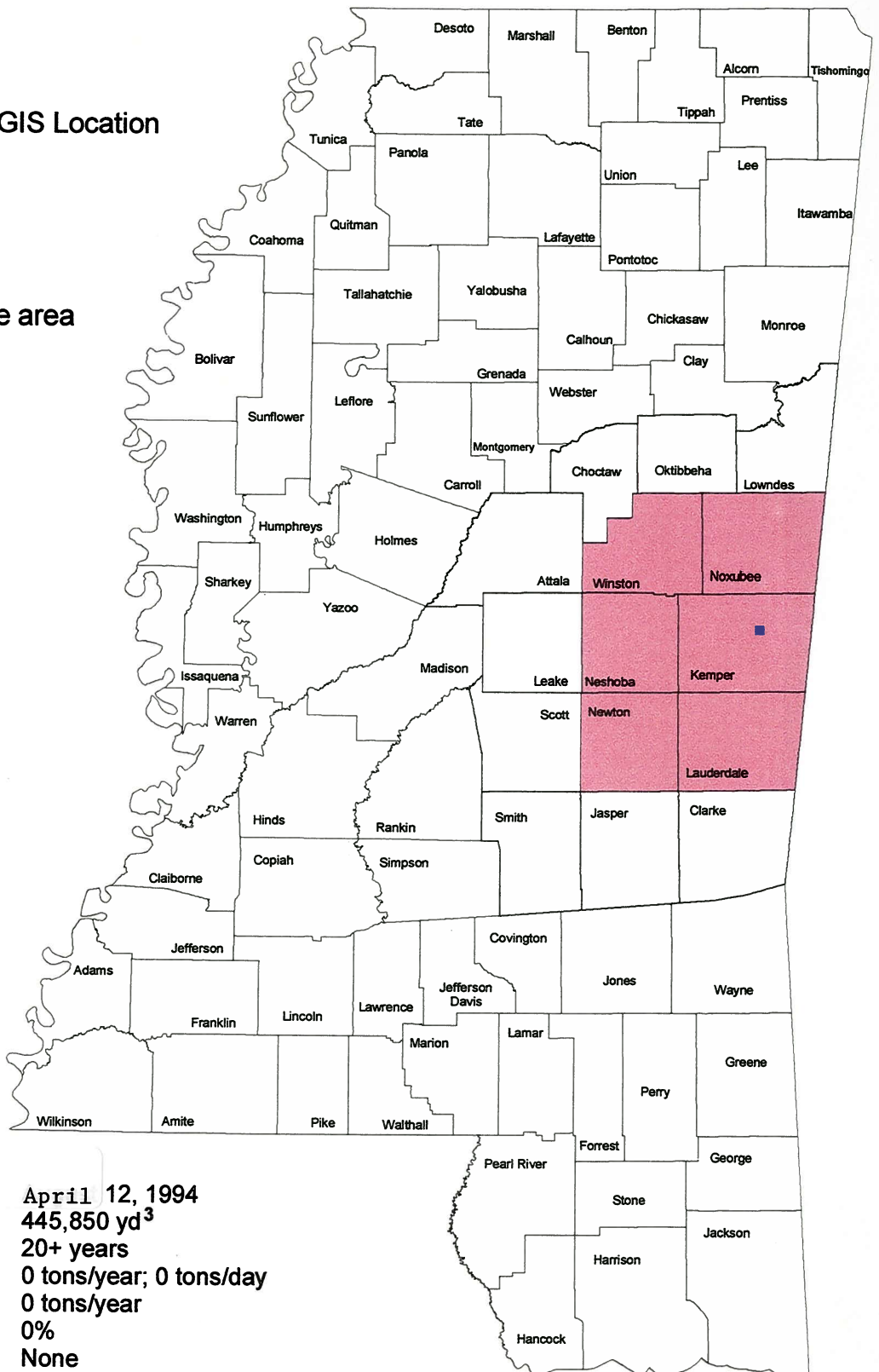

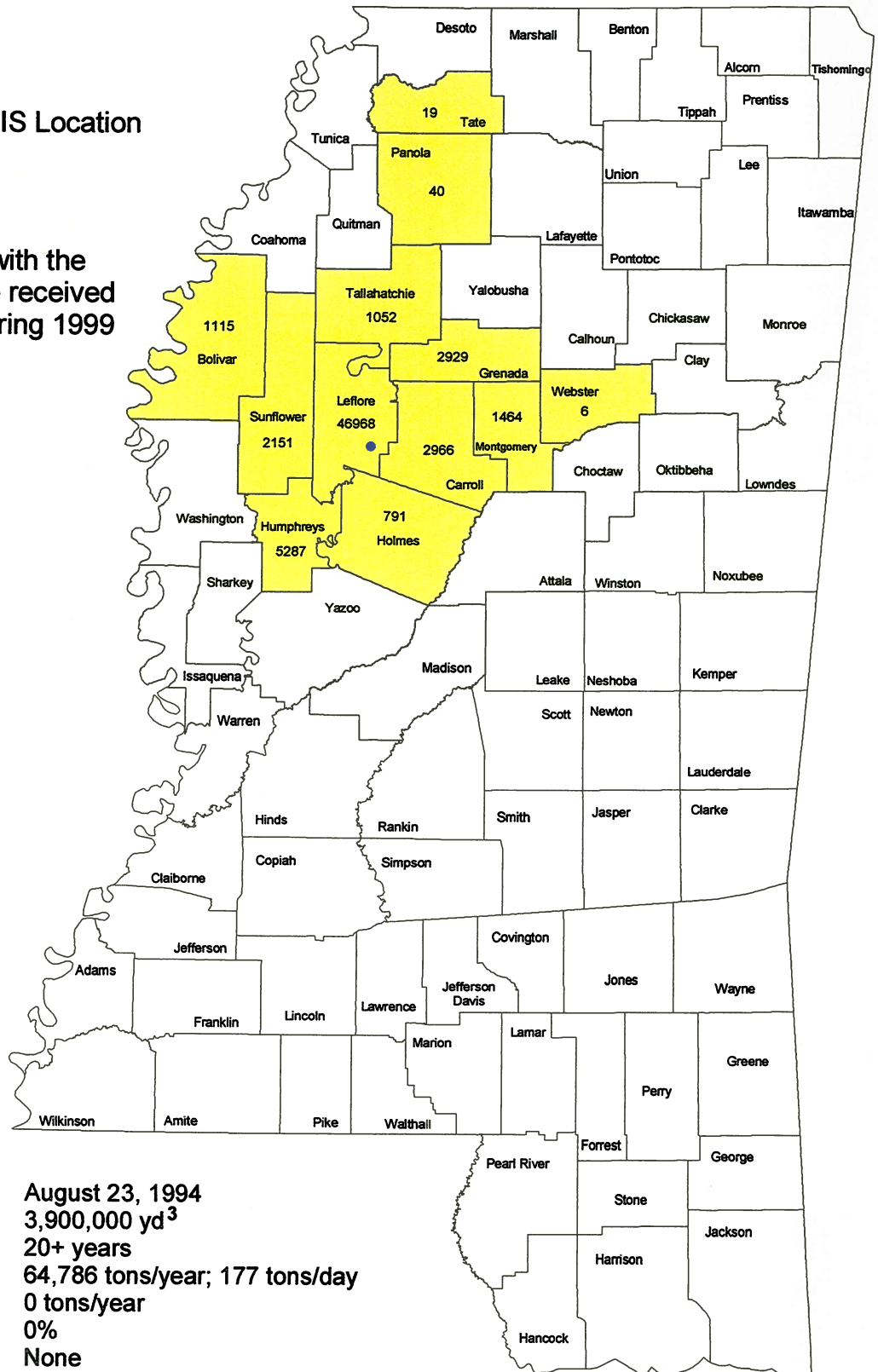

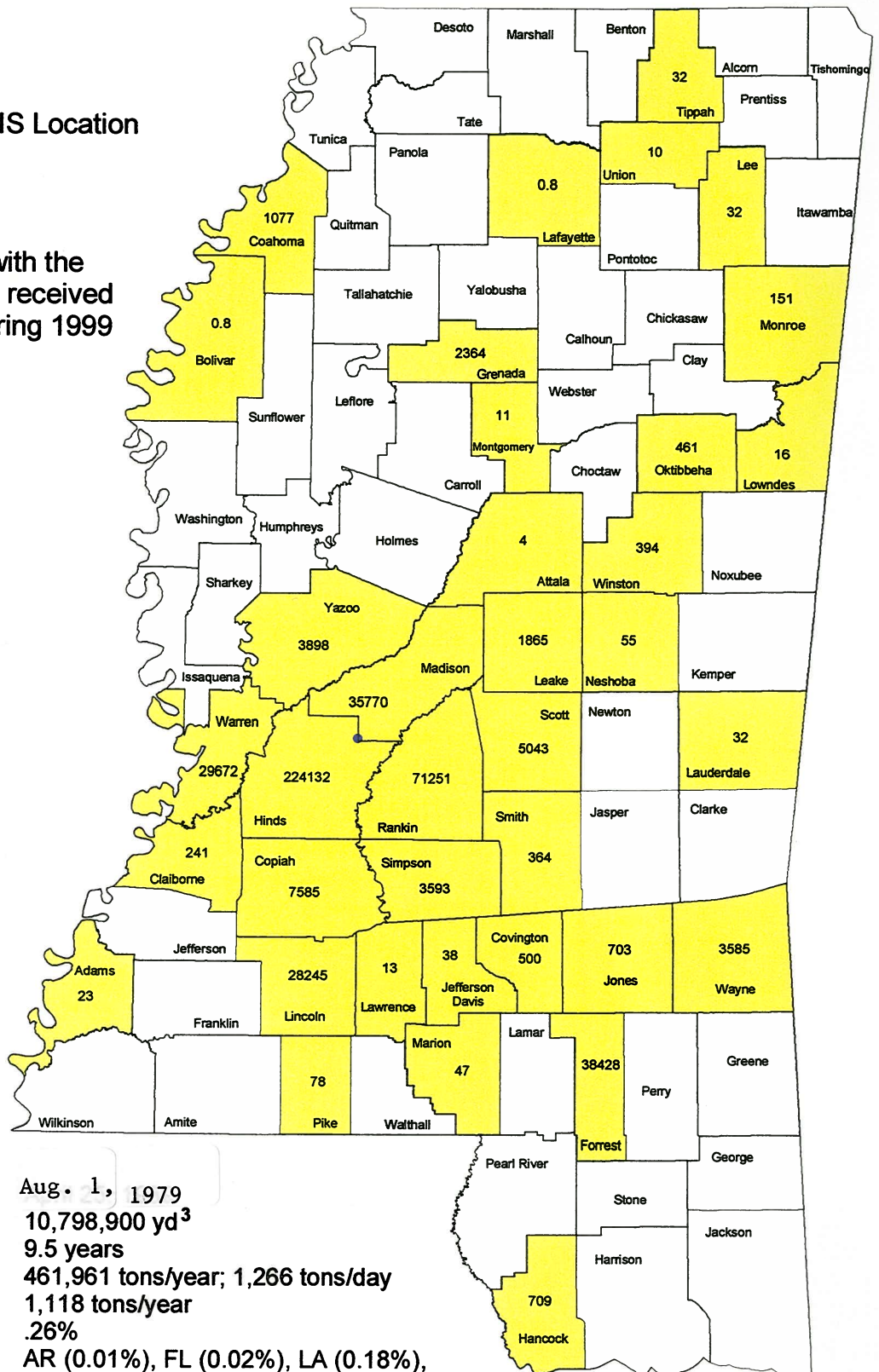

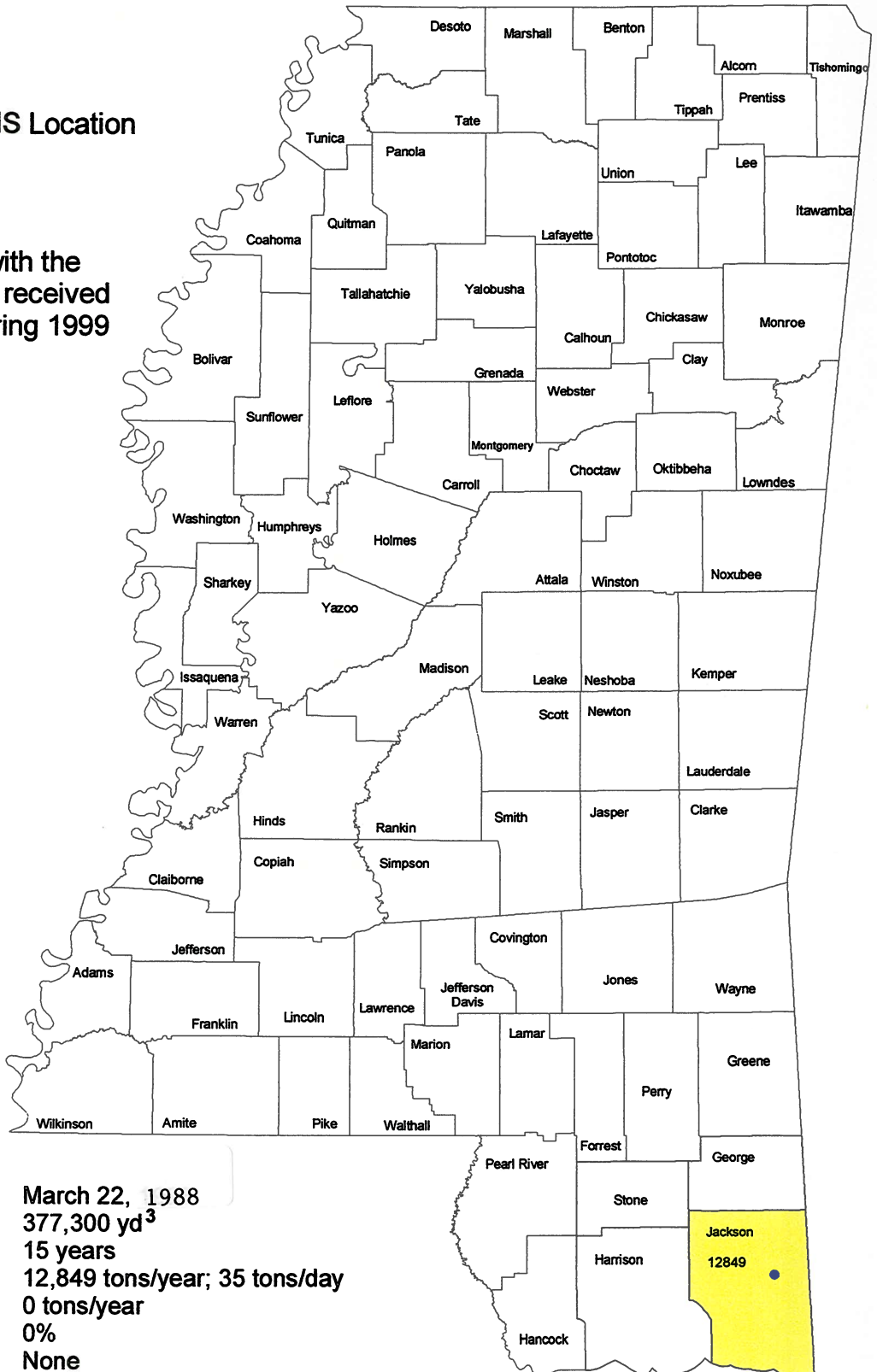

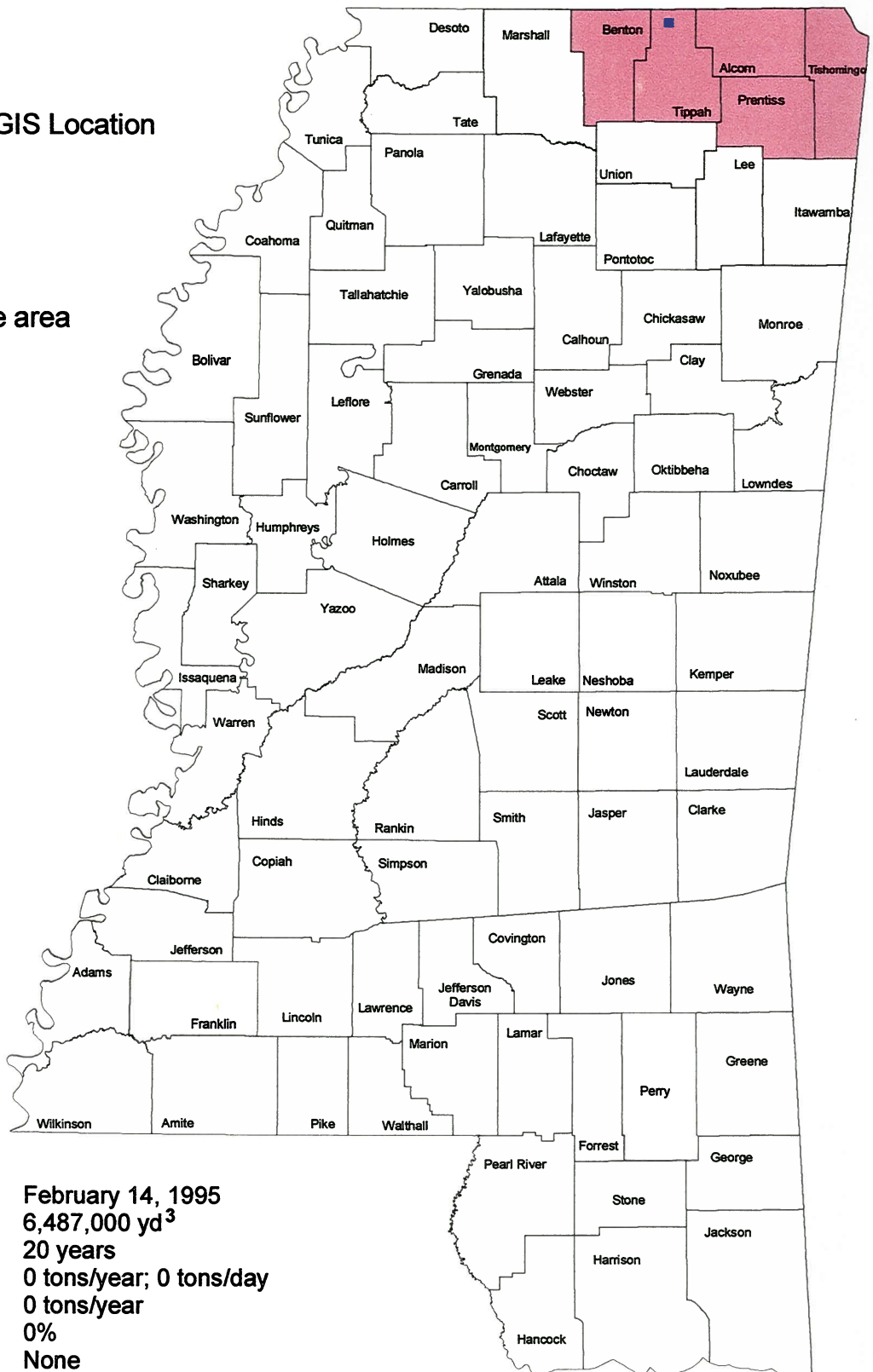

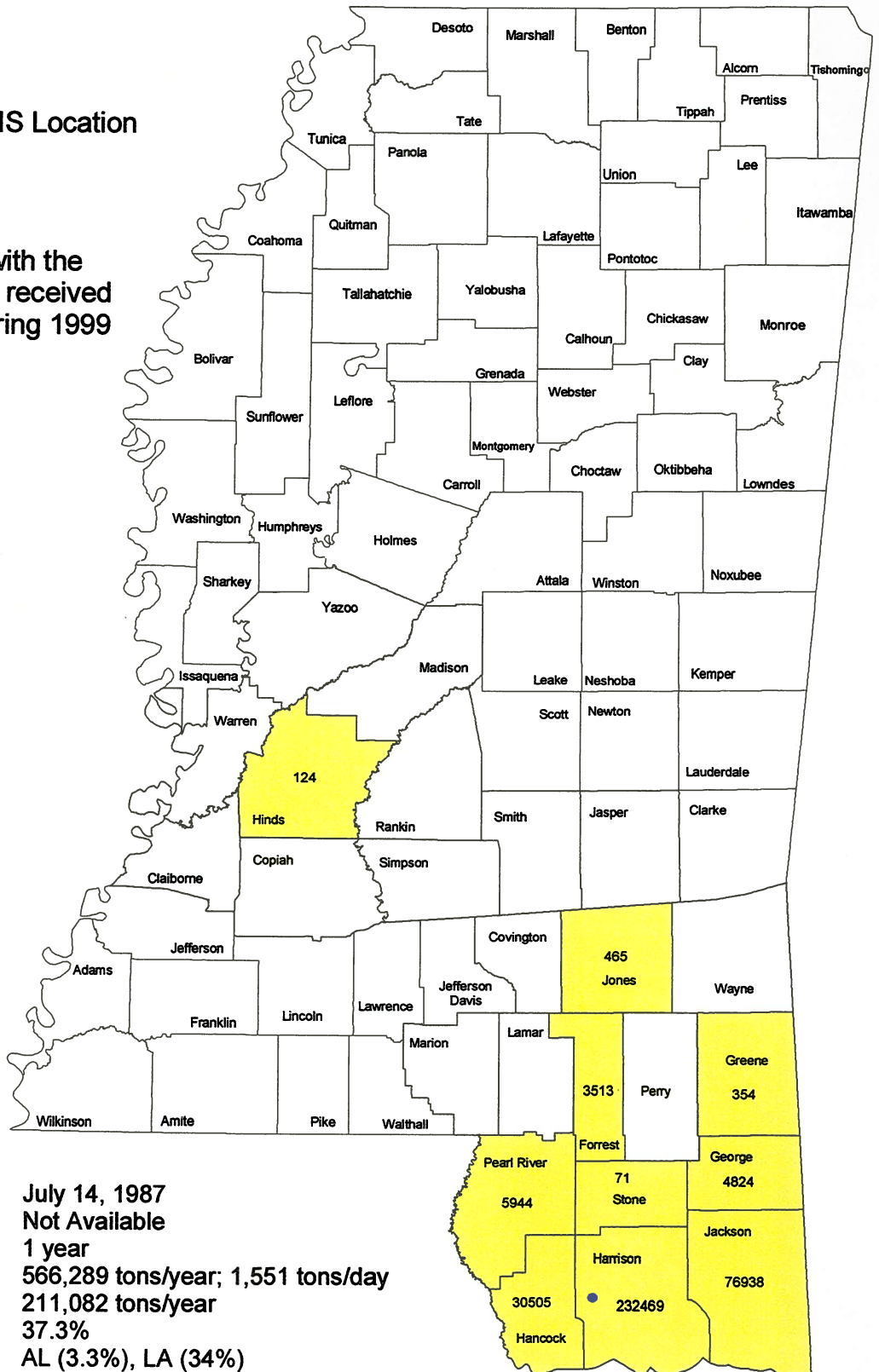

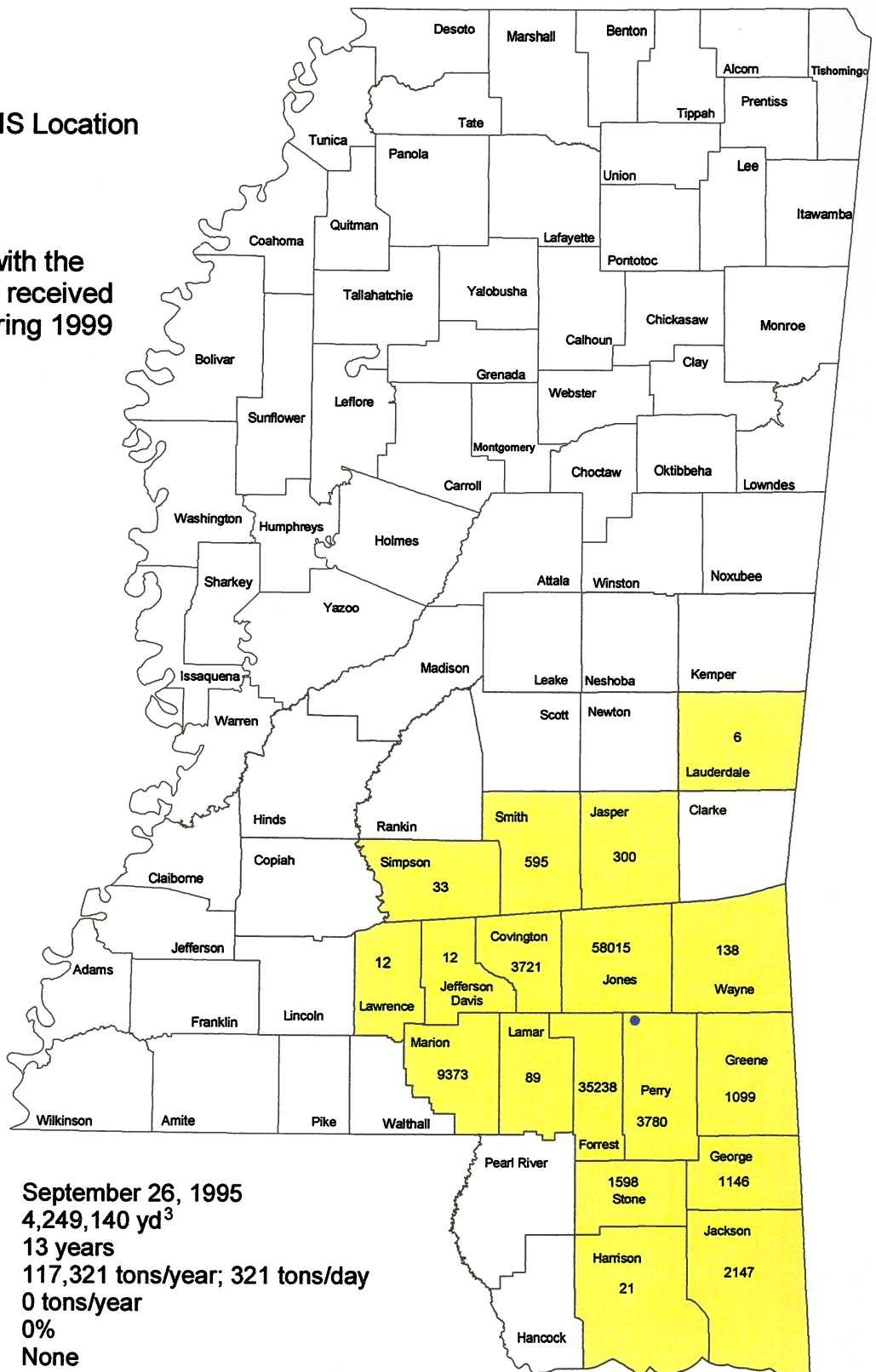

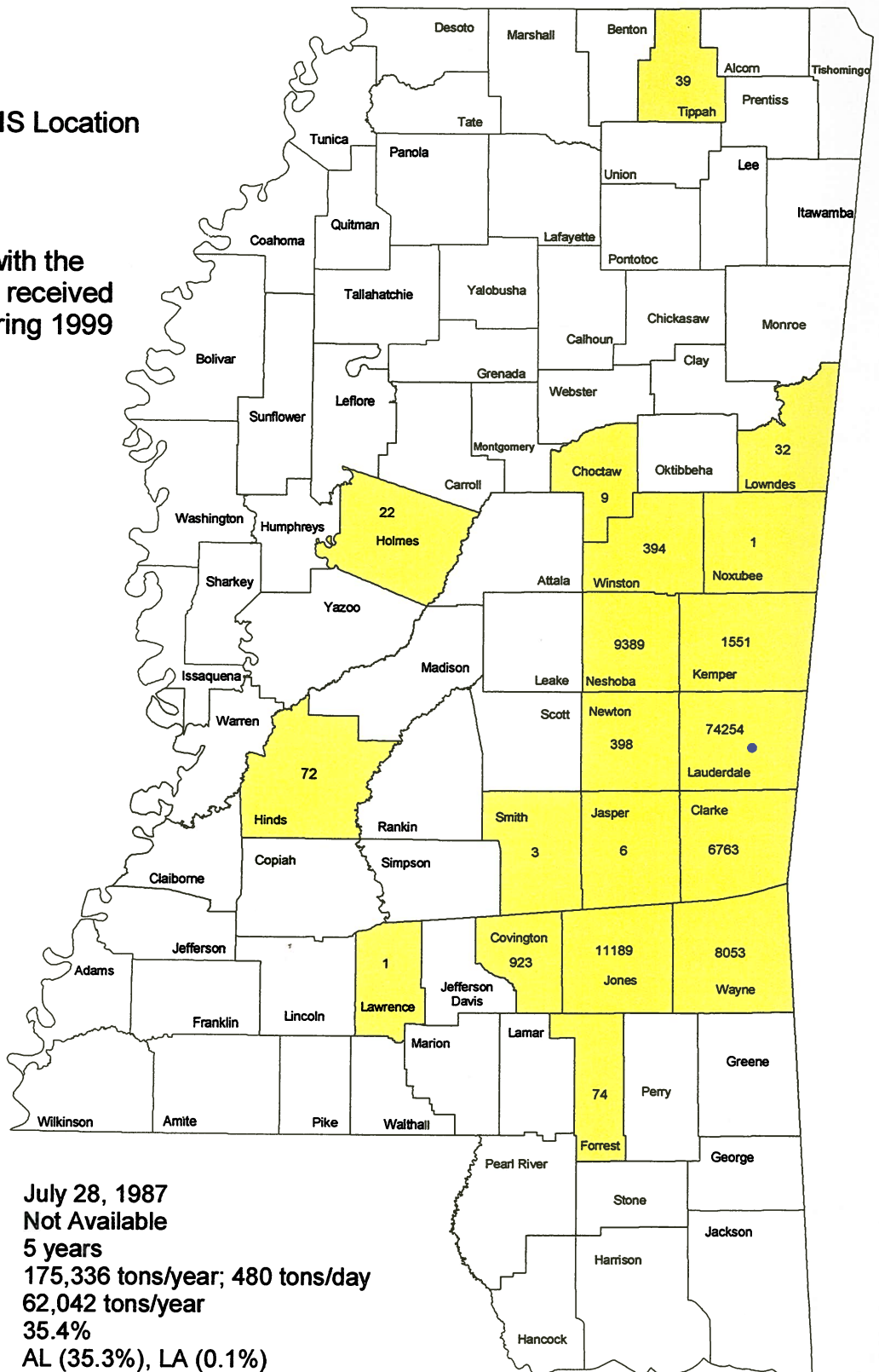

Areas serviced with the amount of waste received (in tons/year) during 1999



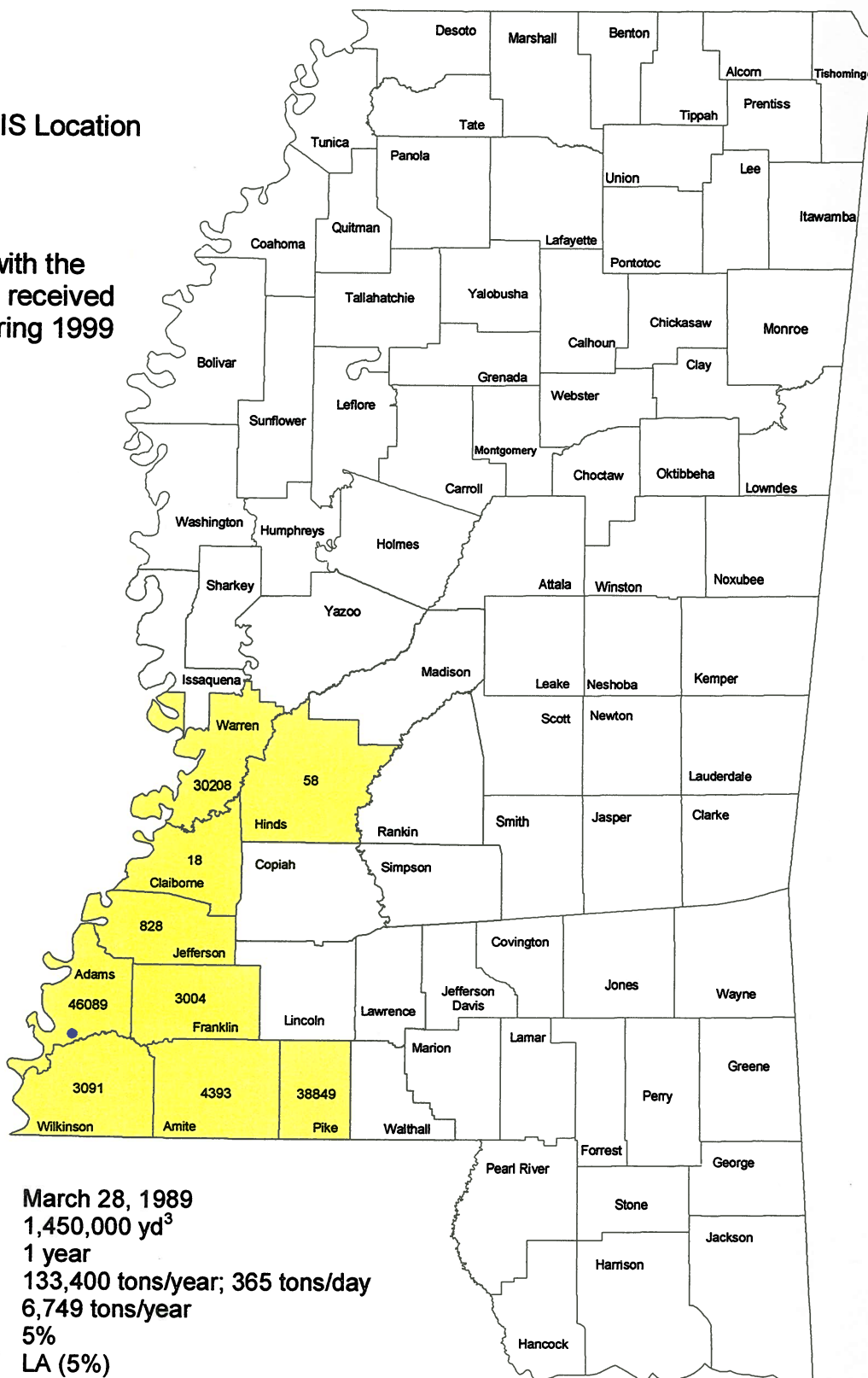

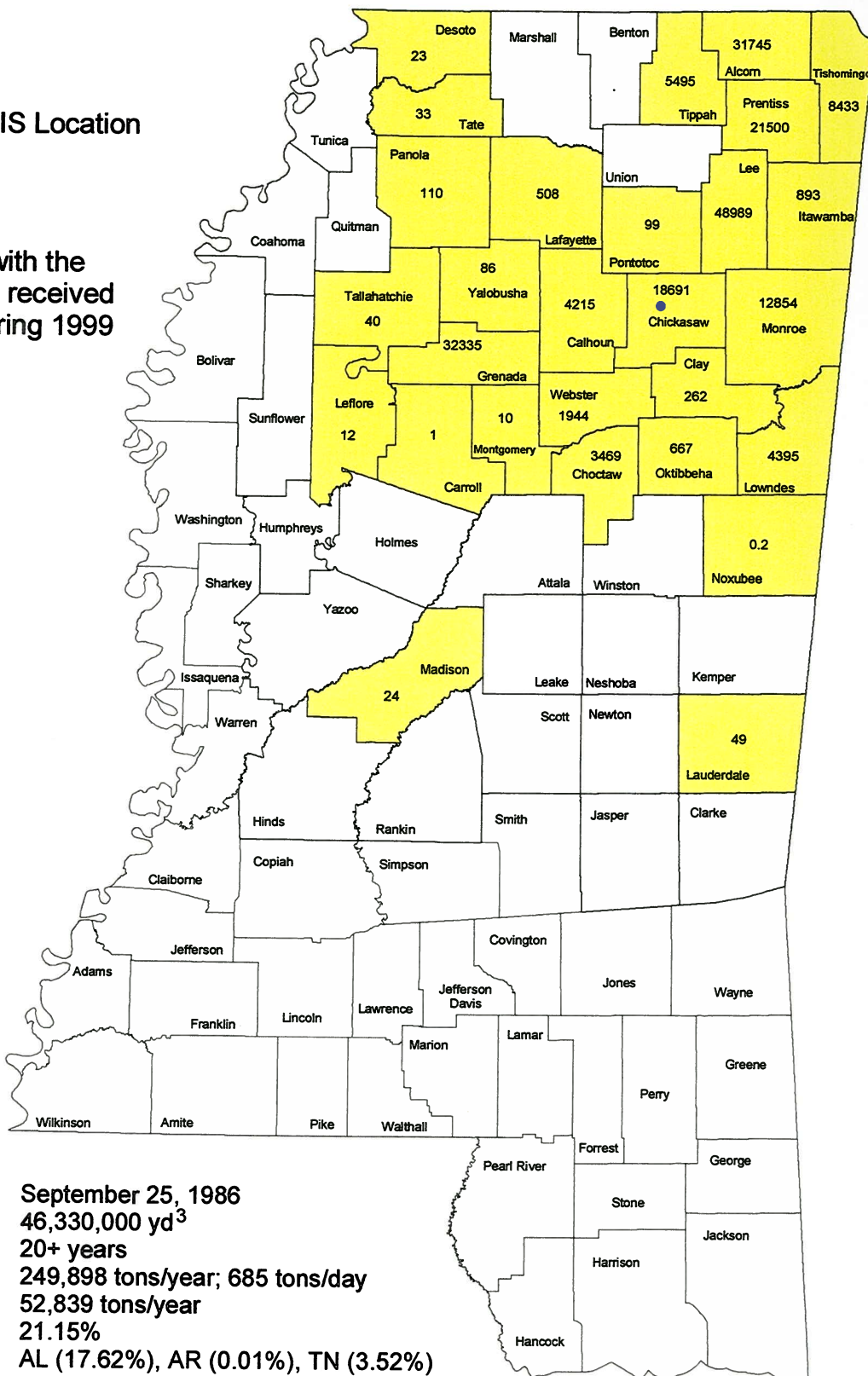

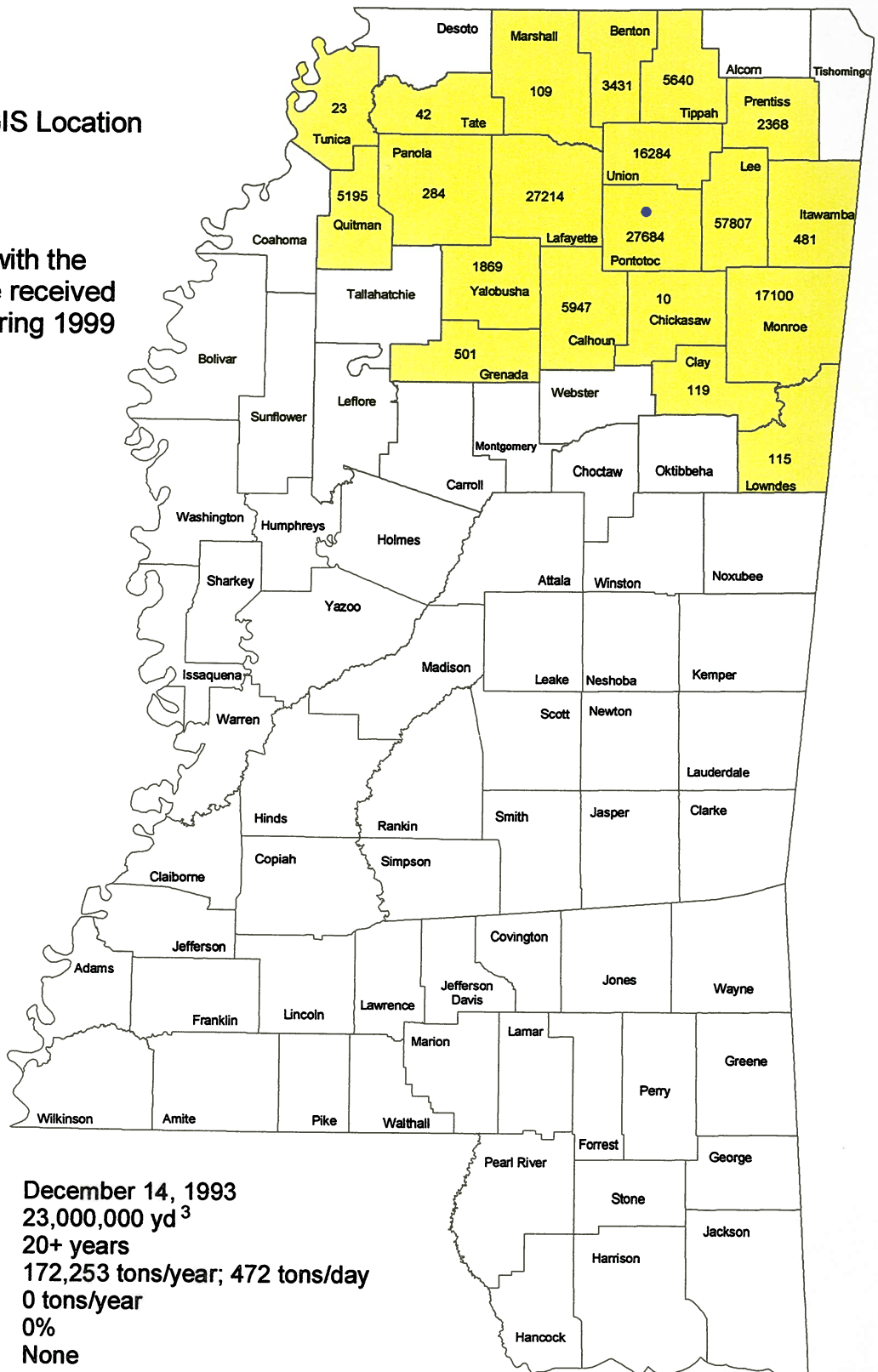
