2. Fees & Costs

- a. **Daily Conference Fee:** GSC will absorb daily conference fees including lunch for GSC Full Members and GSC Benefactors only up to 3 delegates per company membership for this GSC event. Non-Member Carriers would be charged €50 per person per day.
- b. Early Bird Registration Fee for Non-Members: Early bird registration fee of €150 per person is offered to Non-Member Carrier delegates if their registration form is submitted to GSC before 16th October 2015. Next tier discounted fee is 200 Euro per person for registration submitted between 16th October and 2nd November 2015. Registration forms submitted to GSC after 2nd November will attract a registration fee of €300 per person.
- c. GSC Full Members and Benefactors: Registration fee is waived for GSC membership. Note: Membership also includes Carrier Members' wholly owned (100%) subsidiaries. The Members Day scheduled for the Tuesday, 17th November 2015 is exclusively reserved for GSC Carrier Membership only. All GSC Full Members and Benefactors are invited to join the GSC Membership Dinner on the Tuesday 17th November 2015.
- d. Accommodation Rate per night inclusive of taxes and breakfast: Single occupancy HK\$880 net (€105/US\$115) and double occupancy HK\$980 net (€117/US\$128). The room rates are inclusive of taxes, breakfast and complimentary internet/wifi.
- 3. Group Dinner Events: All delegates are invited to attend the Group Dinner sponsored by PCCW Global on the Wednesday 18th November 2015.

4. Registration forms

- a. Each delegate must complete a separate registration form to register for the GSC Forum.
- b. All boxes on the registration forms are mandatory and must be completed in full. Where you are given a selection, please indicate in the appropriate box (Y=Yes, N=No)
- c. All forms must be signed otherwise registrations cannot be confirmed.
- d. Allow up to 3 working days for GSC Admin to process and confirm delegate's registration.
- e. Places are limited and it is advisable to register your names early even if the flight details are not yet available.
- f. For non-member attendees, registration fee would NOT be charged if cancelled prior to 16th October 2015.
- g. All delegates <u>must</u> supply credit card details to secure their hotel reservation. A registration form without a credit card will <u>not</u> be processed.
- h. Completed form with signature must scan email or fax to GSC Admin no later than 2nd November 2015. **Note:**Hotel rooms and competitive rates are not guaranteed for late registrations.
- i. Check-In Time: From 1:00PM. Earlier arrival after 7.30AM is complimentary but subject to availability.
- j. Check-Out Time: 12 Noon. For late checkout, refer to the above.

5. Cancellation

- a. To cancel hotel accommodation reservation you <u>must</u> contact GSC via email **info@gscgroup.org**<u>ASAP not less than 10 days prior to the arrival date</u>.
- b. For cancellation less than 10 days prior to arrival date or No Show, the Hotel will charge the delegate 1 room night.
- c. Registration fee charged by GSC is non-refundable if cancelled on or after 16th October 2015.
- d. If a delegate has registered/paid and unable to attend, a substitute delegate is welcome at no additional charge.

6. Payment

- a. Credit card is the preferred method of payment for ALL fees and charges. Hotel accommodation and in room service costs are to be settled with the Hotel directly. Registration fees and daily conference fees are to be paid to GSC.
- b. Credit card all credit card information received will be passed on to relevant third party as contractually required and for the purpose of this meeting only, but held in the strictest confidence and not passed to a non contracted third party.
- c. **Direct invoice & bank transfer** Not acceptable unless by prior agreement with GSC Executive Council.
