### PLEASE NOTE THE FOLLOWING:

- Some volunteers will be required to use their personal vehicle.
- Volunteers are responsible for their own food, water, sunscreen, etc., to stay comfortable.
- Long durations of standing may be required.
- MANY VOLUNTEERS will spend some time in the sun (there are some canopies, but the sun moves throughout the day).
- All volunteers will be required to sign a waiver (below)
- All volunteers under the age of 18 must have a parent or guardian's signature

### VOLUNTEER JOB DESCRIPTIONS

#### **At Kendall-Jackson Wine Estate & Gardens:**

Start and Finish line set-up - gather, transport and set-up equipment/supplies for the start/finish. There is an AM and PM shift (5-10 ppl)

Parking attendants – direct guests where to park and how to get to either day-of registration or starting line (6-8ppl)

Day-of Registration/ bib pick-up - help get riders checked-in and oriented before the ride (8-10 ppl)

Info. desk – provide info. for where stations are located, ride updates, volunteer check-in (*shared with Registration*)

Goodie bag assembly/hand-out – place donated items into bags, hand out 1 per rider in exchange for bib stub

Celebration glass handout – check IDs, distribute commemorative glass in exchange for bib stub or for Celebration-only attendees (4-6 ppl)

Celebration Ticket takers (beer, wine, food) – Collect bib stubs or tickets in exchange for food or beverage (6-8 ppl)

Celebration Food service – assist with plate-up, handing out of food (6-8 ppl)

Celebration Bussers – collect used plates, glasses, napkins, utensils and dispose of (garbage, recycle, etc.) (10-12 ppl)

Celebration Event breakdown – collect linens, fold-up tables/chairs, take down umbrellas (6-8 ppl)

## VOLUNTEER JOB DESCRIPTIONS, continued

### **Along the route:**

SAG Driving – drive your car along the route and provide basic support and communication for the event, possibly pick up stranded riders and bring them to nearby aid station (10-15 ppl)

AID Station Operations - support riders by preparing and serving them food and fluids (10-15 ppl per station)

AID Station Set-Up and Tear-Down Staff - help build the aid stations, transport supplies and pick up materials and tear-down after the last rider. Oversee aid station operations volunteers. Instructions for each station from Race Director. Commitment is all day (6 - 10 ppl)

Pre-Event equipment and supply logistics and transport - help gather, transport and set-up equipment and supplies for the start/finish and aid stations prior to event. This is a staging operation and trucks or vehicles with larger capacities such as hatchbacks are desirable. (5-15 ppl)

**ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT ("Release")**

*I (or my minor child or ward) wish to volunteer in the 2015 Tour de Fox Wine Country Bike Ride and associated events (collectively, the "Event") benefitting Team Fox and The Michael J. Fox Foundation For Parkinson's Research (jointly, "Team Fox"). Portions of the Event will take place at properties and/or facilities owned by Jackson Family Wines, Inc. or its affiliates (jointly, "JFW").*

*I represent that I am at least 18 years of age as of the date signed, below. (If volunteer is under the age of 18, he or she must be accompanied at the Event by an adult and participant's legal guardian must sign this agreement.)*

*Images Release: Portions of the Event will be photographed, filmed, and/or otherwise recorded. I hereby (i) agree that my name, image, voice and/or likeness may be used by Team Fox and/or JFW for promotion or publicity of Team Fox or the Event ("Promotion"); (ii) grant Team Fox and JFW an irrevocable, perpetual, assignable, and worldwide right to use, publish, distribute, and exhibit the Images for Promotion in any print, digital, or other media or form; and (iii) waive any rights of privacy or publicity I may have in connection therewith.*

*Volunteers driving personal vehicles: I represent that I have a valid California Driver's License, and am responsible for the safe operation of my vehicle and for maintaining adequate personal automobile insurance to cover any accidents or injuries that may arise while volunteering at the Event.*

*Assumption of Risk: I understand that the Event is potentially a hazardous activity, and that accidents during the Event could lead to serious injury, death and/or property damage, both to me and to others. Risks associated with my participation in the Event may include, but are not limited to:*

- medical issues including, but not limited to, dehydration, heat stroke, overexertion, exhaustion, cramps, broken bones, or other injuries;*
- being struck by cyclists, spectators, automobiles, and objects;*
- negligence or carelessness of Team Fox, Event sponsors, vendors, participating groups, communities, JFW, and other owners/lessors of the course or facilities (which may include state and local governmental entities);*
- negligence or carelessness in the implementation or enforcement of any rules, regulations or guidelines related to the Event and/or in the selection, use, or maintenance of any equipment, course, competition, facility or service related to the Events.*

*I understand that the Event may expose me to risks other than those listed above and that the risks may not be reasonably foreseeable to me, Team Fox, JFW, or others. In consideration for being allowed to participate in the Event, I hereby assume all risks associated with the Event, even those risks which are not reasonably foreseeable at this time.*

*Waiver and Release. To the maximum extent permitted by law, I hereby release, waive, forever discharge and covenant not to sue the Releasees (as defined below) from all liabilities, claims, costs, expenses, damages, losses and obligations, of any kind or nature (whether in law or in equity) (collectively, the "Released Liabilities"), which may arise or result (either directly or indirectly) from my participation in the Event. "Releasees" means: Team Fox; Event sponsors; cooperating organizations; Event vendors; Event officials, volunteers, or medical staff; JFW and any and all other owners/lessors of the course or facilities used in the Event, including, but not limited to the (i) State of California; (ii) any and all cities included in the Event course, including but not limited to, Santa Rosa, Windsor, Healdsburg, and Fulton; and (iii) any and all counties included in the Event course, including but not limited to the county of Sonoma; and the directors, owners, affiliates, officers, officials, employees, and agents of any of the aforementioned entities. For the avoidance of doubt, the Released Liabilities include all bodily injury, death and/or property damage I may suffer which arises or results (either directly or indirectly) from my participation in the Event, including through any negligence of the Releasees. I understand and agree that the provisions of this Section "Waiver and Release" are binding on my heirs, assigns and legal representatives. I hereby expressly waive and relinquish any and all rights, defenses and benefits I may have now or in the future under the provisions of California Civil Code section 1542, which provides as follows: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."*

*I affirm that I have read this entire agreement and acknowledge and agree to all terms, obligations, and limitations contained herein on behalf of myself, my successors or estate, and any participating minor child or ward. If applicable, I assert that I have explained the risks of the Event to my child or ward and that he or she understands the agreement.*
