

Security Deposit/Application Fee Policy

- 1. A \$200 Security Deposit and \$75 non-refundable Application Fee, along with a signed 2014-2015 Housing Application and Security Deposit/Application Fee Policy, are required in order to be eligible for placement in the Residence Hall, **The Suites at Laker Landing**, and will be held in accordance with the laws of New York State.
 - Payment methods: 1.) Make check or money order payable in U.S. dollars to **Association Housing**, **LLC**. <u>or</u>
 - 2.) Make credit card payment (online ONLY) at www.flcc.edu/housing
- 2. The \$200 Security Deposit will be refunded if the applicant withdraws his/her application in writing prior to an offer of housing being extended.
- 3. If the applicant <u>declines to attend</u> Finger Lakes Community College (FLCC) by May 1st, the Security Deposit and Application Fee will be returned. In such case, the applicant is required to provide his/her intention to decline attendance in writing to the Office of Housing and Residential Life <u>by May 1st requesting the "May 1st No-Penalty Refund" and must formally notify the FLCC Admissions Office of his/her intention.</u> A refund will be issued when application status is updated to "declined enrollment" with FLCC.
- 4. The \$200 Security Deposit will be refunded to the applicant if his/her application is not accepted. In the event that the Residence Hall is full, the applicant may elect to be placed on a waiting list or request that the Security Deposit be refunded. The \$75 Application Fee is non-refundable.

*Please note that all requests must be made in writing.

- 5. Should the applicant be placed on the waiting list, his or her acceptance for placement will be determined by the date that the \$200 Security Deposit and \$75 Application Fee were received.
- 6. An applicant who is offered housing and declines is no longer entitled to a refund of the \$200 Security Deposit.
- 7. Once the applicant enters into the *Housing License* s/he becomes a "resident." If the resident must withdraw his/her *Housing License* due to circumstances beyond his/her control, a refund or partial refund may be issued if the resident submits a written request for release 60 days prior to his/her scheduled move-in date describing the circumstances and provides a copy of official third-party documentation substantiating the reason(s) beyond his or her control. The \$75 Application Fee and \$200 Security Deposit are non-refundable if a resident withdraws from his/her *Housing License*.
- 8. The \$200 Security Deposit and \$75 Application Fee are not applied to the residents housing bill. Association Housing, LLC works with FLCC to coordinate billing on a semester basis. An initial paper bill for each term will be sent by the housing office, for which a minimum payment amount is due. Finger Lakes Community College will send an e-bill to the student's **FLCC** email account for any balance. Invoices will be sent for both the Fall and Spring semesters and are payable upon receipt.
- 9. A return check fee of \$50.00 will be charged by FLCC for any payment that is returned unpaid.

A billing schedule is offered and described below. **Note**: A <u>minimum payment</u>[†] of 40% will be required on August 1st for the Fall semester and January 1st for the Spring semester, <u>regardless of anticipated financial aid</u>. The remaining balance for each semester is due 60 days after the start of the semester. The following charts outline billing schedules and amounts for the various suite types.

[†] Paying only the minimum amount will limit available excess financial aid for book and meal plan charges. The resident is encouraged to pay in full.
