**California:** Approved specific Preconference Seminars (Nov. 4) and specific Conference Sessions (Nov. 5-7) for continuing education credits. View approved sessions at [www.courts.ca.gov/documents/classlist-providers.pdf](http://www.courts.ca.gov/documents/classlist-providers.pdf).

**CCHI:** Approved accreditation for Preconference Seminars (Nov. 4) and Conference Sessions (Nov. 5-7) that meet CCHI CE guidelines for a total of 44 CE hours. Approved sessions are SEM-D, SEM-E, SEM-F, SEM-H, ET-2, I-2, I-5, I-6, I-7, I-8, I-9, I-11, I-12, IT-1, LAW-1, LT-1, MED-1, MED-3, MED-4, MED-5, MED-6, MED-8, N-2, S-1, S-4, S-5, S-11, S-13, S-14, S-17, ST-4, ST-5, TI-1, TI-2, TRM-2, V-2.

**Colorado:** Approved the Preconference Seminars (Nov. 4) for three (3) continuing education credits per session and the Conference Sessions (Nov. 5-7) for one (1) continuing education credit per one (1) hour of instruction. Interpreters must comply with requirements to include submission of compliance form as per established policy.

**Delaware:** Approved the Preconference Seminars (Nov. 4) for 1 continuing education credit/hour (maximum 3 credits) and the Conference Sessions (Nov. 5-7) for up to twelve (12) continuing education credit-hours. Credit will only be given consideration for attending designated topics and language-specific sessions that are in compliance with Delaware Court Interpreting Program. Proof of attendance must be submitted to the program coordinator within 30 days of attendance.

**Florida:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for up to 20 continuing education credits. Credit will be given for participation in educational activities that are relevant to the work of the courts and enhances the individual's ability to perform his or her work as an interpreter in compliance with Florida policy requirements. Verification of attendance is required with the CIE reporting form at the time of biennial renewal.

**IMIA:** Approved Preconference Seminar H for 0.3 CEUs and each of the following Conference Sessions are approved for 0.1 CEUs: F-7, I-2, I-7, I-6, I-9, J-6, MED-3, MED-5, MED-8, N-2, S-1, for a maximum 0.8 CEUs. Proof of attendance is required for credit to be given in accordance to IMIA established guidelines.

**Kentucky:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for one (1) continuing education credit for each hour of lecture, session, workshop and lectures related to language, law, and specialized interpreting topics attended. Interpreters will need to submit proof of attendance and continuing education approval form to the Kentucky Administrative Office of the Courts to be considered to receive credit accordingly.

**NAJIT:** No longer requires NAJIT certified interpreters to comply with continuing education credits.

**Nebraska:** The application is currently being reviewed. Information will be posted when it becomes available.

**New Mexico:** Approved the Preconference Seminars (Nov. 4) for three (3) continuing education credits per seminar and the Conference Sessions (Nov. 5-7) for one (1) continuing education credit per approved session. Credit will only be given for attending sessions that have topics relevant to court procedures and court interpreting. Verification of attendance must be provided.

**Ohio:** Approved the Preconference Seminars (Nov. 4) for six (6) continuing education credit hours and the Conference Sessions (Nov. 5-7) for sixteen (16) continuing education credit hours. Proof of attendance is required and credit will only be given in accordance to established guidelines.

**Oregon:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for continuing education credits according to Oregon policy requirements. Interpreters will need to provide proof of attendance, course description, and number of contact hours upon completion of the conference to Court Interpreter Services. Credit will only be given for attending educational sessions that meet policy requirements.

**Pennsylvania:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for up to twelve (12) continuing education credits. Credit will only be awarded for attending educational sessions, not business sessions. Submission of the Continuing Education Approval form and proof of attendance of each session is required and must be submitted after attending the events.

**Texas:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for up to eighteen (18) continuing education credits hours and two (2) continuing education credits hours (ethics). Proof of attendance is required and compliance to JBCC statutes, rules, and policies.

**Tennessee:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for twenty-four (24) General continuing education credits and twenty-two (22) Foreign Language continuing education credits for selected educational sessions. Proof of attendance is required and compliance to established policies.

**Utah:** Approved the Preconference Seminars (Nov. 4) and the Conference Sessions (Nov. 5-7) for one (1) continuing education credit per one (1) hour of instruction for designated topics which are in compliance with Utah policy requirements for certified court interpreters.

**Washington:** Approved Preconference Seminar H (Nov. 4) for three (3) continuing education credits and related Conference Sessions (Nov. 5-7) for up to twelve (12) continuing education credits (general credits). Proof of attendance is required and compliance to requirements, policies, and procedures established by Washington Court Interpreter Program.
