# Purpose of this form

Use this form to declare that you **and** the other person named in the application for child support are named as parents of the child(ren) in the register of births.

If an application for a child support assessment is made in relation to a child, the Australian Government Department of Human Services needs additional information to help progress the claim. This is to make sure the persons who are being assessed for the costs of the child(ren) are the parents of the child(ren).

## International customers

You can contact a person listed under 'Authorised persons' (at the end of this form) as a witness at the nearest Australian Embassy, High Commission or Consulate. Please note that the persons listed as authorised persons must be registered or hold the relevant position in Australia.

## **Online Services**

You can access your Child Support online account through myGov. myGov is a fast and secure way to access a range of government services online with one username and password. You can create a myGov account at **my.gov.au** and link it to your Child Support online account.

**IMPORTANT**: You must be certain that the person you are naming as the parent is in fact named in the register of births for the child(ren) as a parent. This means you have either:

- sighted a full copy of the child(ren)'s birth certificate and confirmed the person is named as a parent, or
- confirmed with Births, Deaths and Marriages that the person is named as a parent for the child(ren) in the register.

If the parent applying for a birth certificate for the child names the other parent in the application, but the other parent does not complete and send in an independent declaration, then the other parent may not in fact be registered as a parent of the child and you could be making a false declaration.

#### 10 Penalty for false statement

A person who intentionally makes a false statement in a statutory declaration is quilty of an offence, the punishment for which is imprisonment for a term of 4 years — see section 11 of the Statutory Declarations Act 1959.

Chapter 2 of the Criminal Code applies to all offences against the Statutory Declarations Act 1959 — see section 5A of the Statutory Declarations Act 1959.

# **Authorised persons**

According to the *Statutory Declarations Act 1959* a statutory declaration may be made before:

- (1) a person who is currently licensed or registered under a law to practise in one of the following occupations:
  - chiropractor
  - dentist
  - legal practitioner
  - medical practitioner
  - nurse
  - · optometrist
  - patent attorney
  - pharmacist
  - physiotherapist
  - psychologist
  - trade marks attorney, or
  - · veterinary surgeon.
- (2) a person who is enrolled on the roll of the Supreme Court of a state or territory or the High Court of Australia, as a legal practitioner (however described).
- (3) a person who is in the following list:
  - agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
  - Australian consular officer or Australian diplomatic officer (within the meaning of the Consular Fees Act 1955)
  - hailiff
  - bank officer with 5 or more continuous years of service
  - building society officer with 5 or more years of continuous service
  - · chief executive officer of a Commonwealth court
  - clerk of a court
  - · commissioner for affidavits
  - · commissioner for declarations
  - credit union officer with 5 or more years of continuous service
  - employee of the Australian Trade Commission who is:
    - (a) in a country or place outside Australia
    - (b) authorised under Paragraph 3(d) of the Consular Fees Act 1955
    - (c) exercising his or her function in that place
  - employee of the Commonwealth who is:
    - (a) in a country or place outside Australia, and
    - (b) authorised under Paragraph 3(c) of the Consular Fees Act 1955
    - (c) exercising his or her function in that place
  - fellow of the National Tax Accountants' Association
  - finance company officer with 5 or more years of continuous services
  - holder of a statutory office not specified in another item in this list
  - judge of a court
  - justice of the peace
  - magistrate

- marriage celebrant registered under subdivision C of division 1 of part IV of the Marriage Act 1961
- master of a court
- member of Chartered Secretaries Australia
- member of Engineers Australia, other than at the grade of student
- member of the Association of Taxation and Management Accountants
- member of the Australasian Institute of Mining and Metallurgy
- member of the Australian Defence Force who is:
  - (a) an officer
  - (b) a non-commissioned officer within the meaning of the Defence Force Discipline Act 1982 with 5 or more years of continuous service
  - (c) a warrant officer within the meaning of that Act
- member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants
- member of:
  - (a) the parliament of the Commonwealth
  - (b) the parliament of a state
  - (c) a territory legislature
  - (d) a local government authority of a state or territory
- minister of religion registered under subdivision A of division 1 of part IV of the Marriage Act 1961
- notary public
- permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public
- · permanent employee of:
  - (a) the Commonwealth or a Commonwealth authority
  - (b) a state or territory or a state or territory authority
  - a local government authority with 5 or more years of continuous service who is not specified in another item in this list
- person before whom a statutory declaration may be made under the law of the state or territory in which the declaration is made
- police officer
- · registrar or deputy registrar of a court
- senior executive service employee of:
  - (a) the Commonwealth or a Commonwealth authority
  - (b) a state or territory or a state or territory authority
- sheriff
- · sheriff's officer, or
- teacher employed on a full-time basis at a school or tertiary education institution.
