Individuals who have been convicted of a sexual offense are not eligible to serve in an employment or volunteer capacity for Texas A&M affiliated camps or enrichment programs in positions responsible for the direct or indirect supervision of campers or program participants, or which may allow for unsupervised access to, or interaction with campers or program participants.
