Fairbanks General Code provides that failure to register and pay for a business license is punishable by up to a \$600 fine and/or imprisonment for each offense. Each day of violation constitutes a separate offense. All business licenses expire on December 31. If you already hold a City business license, you will receive a renewal in January and you **should not use this form**. Renewals are due the **last day of February**. Fees and licenses are nontransferable and nonrefundable.

Sign your application and return it to the address above with a check, money order or credit card authorization. **This license will not be processed unless accompanied by payment.** You may email or fax your application with credit card authorization (if emailing or faxing, do not also mail in the application). All checks should be made payable to the City of Fairbanks.
