<u>Crosswalk Repainting:</u> Mr. Carrigan said he spoke with Mr. Fachin, Director of Public Works, about painting the crosswalks at R.M. Miano and Los Banos Elementary Schools as well as San Luis High School. After examining the crosswalks, Mr. Fachin suggested painting the Miano crosswalk and power washing the LBE and SLHS crosswalks. He said power washing has had successful results in the past. Mr. Villalta inquired about the possibility of painting a crosswalk on the corner of Washington and 7th Streets. Mr. Carrigan said he would look into it.

Repainting Crosswalks

B Street Property - School & Joint Use Park: Dr. Tietjen said the District is in discussions with Larry Anderson and Greg Hostetler regarding the B Street and Place Road property. Trustees would like to close escrow on property they are considering for a new elementary school; but would like to know if the land set aside next to the B Street property is *dedicated* or *designated* as a park. Strategies for closing escrow would depend on the status of the property. The District would like to include a joint-use park in the design for a new elementary school which would be used by the school during the day and available for public access after school and on weekends. Mr. Carrigan said he would ask staff to research the status of the B Street park property.

Other: Mr. Villalta inquired about the adult swim program at Pacheco High School. Dr. Tietjen said there did not seem to be a big demand for the swim program this year. Mr. Carrigan said the City may pursue grants for a community swimming pool or splash parks. He said splash parks are becoming very popular with cities because they cost less than pools and present a reduced liability risk.
