On the above date and time units responded to the above location in regards to an Attempted Armed Robbery.

The caller advised another male pulled a gun and tried to rob him of his money. At first the victim could not be located. He was located at the McDonalds in Holly Hill.

Investigation revealed that the suspect vehicle had been located backed in at 417 Wilson Avenue. One suspect was taken into custody, another suspect fled to a back bedroom and locked the door and advised that if police came in he would commit suicide.

At approximately 1624 hours Dillon Calisi W/M 03/01/93 exited the residence and surrender. Calisi has an open warrant for Resisting Arrest with Violence.

This is an active ongoing investigation and the release will be updated as the investigation is ongoing.



NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 16 day of November, 2015, at approximately 0304 a.m. p.m. at 212 Madison Ave DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On Monday, November 16, 2015, at 3:04 PM officers with the Daytona Beach Police Department responded to the area of 212 Madison Ave in
 2 reference to a 911 call about a robbery. Dispatch advised the caller hung up before any information was obtained. Dispatched advised the Phase 2
 3 location of the call was at 212 Madison Ave. Numerous officers responded to the scene but were unsuccessful at locating the victim. Several minutes
 4 later a Holy Hill Police Officer advised the Daytona Beach Police Officers that they were in contact with the victim of the robbery at 151 Ridgewood
 5 Ave Holly Hill, FL (McDonald's). Officer L. Timmer responded to their location to make contact with the victim.
 6
 7 David Clarke (V-1) stated the following: On today's date he was approached by a white male wearing a white tank top and dark colored shorts. D.
 8 Clarke (V-1) stated the white male, later identified as Dillon Calisi (A-1), asked him to take a walk and have a smoke. D. Clarke agreed and they both
 9 walked south bound on Ridgewood Ave to Madison Ave where they turned east, then began to walk east bound on Madison Ave. When they were in
 10 the 200 block of Madison Ave a tan Buick passenger vehicle pulled up beside them being driven by a black male, later identified as Benjamin Bennett
 11 (A-2). D. Calisi (A-1) grabbed the victim by the front of his shirt and threw him up against the left rear of the vehicle. D. Calisi (A-1) then opened the
 12 rear door and forcibly abducted D. Clarke (A-1) by pushing him inside of the vehicle against his will without lawful authority and with the intent of
 13 committing a robbery. Once D. Clarke (V-1) and D. Calisi (A-1) were inside of the vehicle B. Bennett (A-2) moved from the driver's seat to the front
 14 passenger's seat. D. Calisi (A-1) yelled to B. Bennett (A-2) to, "Grab the forty!" At which time B. Bennett (A-2) drew a black in color handgun from
 15 under the front passenger seat. B. Bennett (A-2) pointed the handgun at D. Clarke (V-1) and stated, "Give us your money!" D. Clarke (V-1) advised

16 the subjects that he did not have any money. D. Calisi (A-1) pulled D. Clarke's (V-1) pants off of him and went through the pockets. After D. Calisi
 17 (A-1) did not locate any money, B. Bennett (A-2) yelled, "Check his socks!" D. Calisi (A-1) pulled D. Clarke's (V-1) shoes and socks off then went
 18 through those items. It should be known that no money or any other property was obtained from D. Clarke (V-1) by the defendant's. D. Clarke (V-1)
 19 then advised D. Calisi (A-1) pushed him out of the vehicle and threw his clothes on the ground. D. Calisi (A-1) got into the driver's seat and drove the
 20 vehicle from the scene, east bound in the 200 block of Madison Ave. D. Clarke was able to obtain the license plate number of the vehicle. D. Clarke
 21 stated that he called 911 as he walked back to his bicycle that was parked at the McDonald's. D. Clarke (V-1) completed a sworn witness statement
 22 and does wish to prosecute. D. Clarke (V-1) also stated that he is able to positively identify both subjects if seen again.

 24 On Monday, November 16, 2015, at approximately 3:18 PM Officers Jayson Wallace, Michael Cherry, Richard Maher and Brandon Jacobs
 25 responded to 417 Wilson Ave being the address on file for Florida tag CRB-I68. Officer R. Maher drove past the residence and was able to locate a
 26 tan colored Buick passenger vehicle backed into the driveway at 417 Wilson Ave. The vehicle appeared to be unoccupied. The officers then parked
 27 their vehicles to the south of the residence and walked up to the residence on foot. Upon approaching the residence the officers observed a black
 28 male exit the front door who matched the description of the robbery suspect, B. Bennett (A-2). Once B. Bennett (A-2) observed the officers walking to
 29 the residence he turned around and went back inside. Officers J. Wallace and R. Maher ran to the rear of the residence while Officers M. Cherry and
 30 B. Jacobs covered the front. While in the rear of the residence Officer J. Wallace and R. Maher observed the same black male, B. Bennett (A-2) run
 31 into the kitchen area as if he was attempting to conceal an item from the officers view. Multiple subjects were on the back porch area of the
 32 residence, including a female who stated that she was the homeowner of 417 Wilson Ave. Officer J. Wallace instructed B. Bennett (A-2) to exit the
 33 residence, from a rear door, in which he did from the kitchen area. He was then detained. Officer R. Maher read B. Bennett (A-2) "Miranda Warnings"
 34 from a department issued card. While Officer R. Maher questioned B. Bennett (A-2) Officer J. Wallace contacted Amanda Padgett (O-1) and asked
 35 her for consent to search the residence. Amanda Padgett opened both of her hands while raising her arms in the air and stated, "Yes, you can
 36 search." Officer J. Wallace then notified Officer M. Cherry that they should clear the residence for any other persons involved in the incident. Amanda
 37 Padgett again stated that she gives the officers consent to search while being video recorded via Officer M. Cherry's Axon Flex camera. While the
 38 officers cleared the residence they found a locked rear bedroom door. Officer J. Wallace asked Amanda Padgett (O-1) if there were any other people
 39 in the residence and should the rear bedroom door be locked. Amanda Padgett (O-1) replied that no one should be in the residence and that there is
 40 no reason that the rear bedroom door is locked. Officers J. Wallace and M. Cherry then knocked on the door and gave announcements that they
 41 would breach the door if the person inside does not exit. The officers then heard a voice state, "If anybody comes in here I'm going to shoot myself in
 42 the head!" Officer J. Wallace then advised, via the radio, that he had a suicidal barricaded subject in a locked bedroom. The officers were able to
 43 remove all other occupants of the residence and secure the perimeter, to hold for additional units. Officer R. Maher was able to verbally contact the
 44 subject to negotiate with him (See R. Maher's supplement). After negotiating for some time the subject willfully exited the residence and was taken
 45 into custody without further incident. D. Calisi (A-1) was positively identified by his Florida ID card. It should be known that D. Calisi (A-1) has active
 46 warrants open for his arrest (See additional S.A. 707).

 51 The defendant's were transported to the Daytona Beach Police Department and interviewed by C.I.D. (See supplement). Amanda Padgett (O-1)
 52 completed a consent to search form that was tagged into evidence by Officer J. Wallace. Officers and Detectives searched the residence and the
 53 vehicle and were unable to locate a handgun.




16 the subjects that he did not have any money. D. Calisi (A-1) pulled D. Clarke's (V-1) pants off of him and went through the pockets. After D. Calisi
 17 (A-1) did not locate any money, B. Bennett (A-2) yelled, "Check his socks!" D. Calisi (A-1) pulled D. Clarke's (V-1) shoes and socks off then went
 18 through those items. It should be known that no money or any other property was obtained from D. Clarke (V-1) by the defendant's. D. Clarke (V-1)
 19 then advised D. Calisi (A-1) pushed him out of the vehicle and threw his clothes on the ground. D. Calisi (A-1) got into the driver's seat and drove the
 20 vehicle from the scene, east bound in the 200 block of Madison Ave. D. Clarke was able to obtain the license plate number of the vehicle. D. Clarke
 21 stated that he called 911 as he walked back to his bicycle that was parked at the McDonald's. D. Clarke (V-1) completed a sworn witness statement
 22 and does wish to prosecute. D. Clarke (V-1) also stated that he is able to positively identify both subjects if seen again.

 24 On Monday, November 16, 2015, at approximately 3:18 pm Officers Jayson Wallace, Michael Cherry, Richard Maher and Brandon Jacobs
 25 responded to 417 Wilson Ave being the address on file for Florida tag CRB-I68. Officer R. Maher drove past the residence and was able to locate a
 26 tan colored Buick passenger vehicle backed into the driveway at 417 Wilson Ave. The vehicle appeared to be unoccupied. The officers then parked
 27 their vehicles to the south of the residence and walked up to the residence on foot. Upon approaching the residence the officers observed a black
 28 male exit the front door who matched the description of the robbery suspect, B. Bennett (A-2). Once B. Bennett (A-2) observed the officers walking to
 29 the residence he turned around and went back inside. Officers J. Wallace and R. Maher ran to the rear of the residence while Officers M. Cherry and
 30 B. Jacobs covered the front. While in the rear of the residence Officer J. Wallace and R. Maher observed the same black male, B. Bennett (A-2) run
 31 into the kitchen area as if he was attempting to conceal an item from the officers view. Multiple subjects were on the back porch area of the
 32 residence, including a female who stated that she was the homeowner of 417 Wilson Ave. Officer J. Wallace instructed B. Bennett (A-2) to exit the
 33 residence, from a rear door, in which he did from the kitchen area. He was then detained. Officer R. Maher read B. Bennett (A-2) "Miranda Warnings"
 34 from a department issued card. While Officer R. Maher questioned B. Bennett (A-2) Officer J. Wallace contacted Amanda Padgett (O-1) and asked
 35 her for consent to search the residence. Amanda Padgett opened both of her hands while raising her arms in the air and stated, "Yes, you can
 36 search." Officer J. Wallace then notified Officer M. Cherry that they should clear the residence for any other persons involved in the incident. Amanda
 37 Padgett again stated that she gives the officers consent to search while being video recorded via Officer M. Cherry's Axon Flex camera. While the
 38 officers cleared the residence they found a locked rear bedroom door. Officer J. Wallace asked Amanda Padgett (O-1) if there were any other people
 39 in the residence and should the rear bedroom door be locked. Amanda Padgett (O-1) replied that no one should be in the residence and that there is
 40 no reason that the rear bedroom door is locked. Officers J. Wallace and M. Cherry then knocked on the door and gave announcements that they
 41 would breach the door if the person inside does not exit. The officers then heard a voice state, "If anybody comes in here I'm going to shoot myself in
 42 the head!" Officer J. Wallace then advised, via the radio, that he had a suicidal barricaded subject in a locked bedroom. The officers were able to
 43 remove all other occupants of the residence and secure the perimeter, to hold for additional units. Officer R. Maher was able to verbally contact the
 44 subject to negotiate with him (See R. Maher's supplement). After negotiating for some time the subject willfully exited the residence and was taken
 45 into custody without further incident. D. Calisi (A-1) was positively identified by his Florida ID card. It should be known that D. Calisi (A-1) has active
 46 warrants open for his arrest (See additional S.A. 707).

 48 Officer L. Timmer responded to the scene with D. Clarke (V-1) for a show up. D. Clarke (V-1) was able to immediately identify both D. Calisi (A-1)
 49 and B. Bennett (A-2) as the subjects who made an attempt to rob him (See L. Timmers supplement).

 51 The defendant's were transported to the Daytona Beach Police Department and interviewed by C.I.D. (See supplement). Amanda Padgett (O-1)
 52 completed a consent to search form that was tagged into evidence by Officer J. Wallace. Officers and Detectives searched the residence and the
 53 vehicle and were unable to locate a handgun.


