Remove old asphalt at the backstop, replace with brick pavers. Boy scouts helping with projects. Fence to enclose the field. Hope to get drinking fountain installed, and more landscaping done. Whole backstop needs to be replaced with possible future funds. As per discussion. New bleachers and a shelter with bathroom. Formally requested primary use of the fields for 2015. Possible fall league to be run through parks. As per discussion.
