## 2014 Registration Packet



**This is a recreational volleyball league with three divisions of play offered.  
A, B and C Leagues for any male or female 18 years of age or older.**

Cost: \$60.00 + \$10 Winter Sports Player Fee  
Includes single elimination tournament

Deadlines: Dec. 11, 2013 no late fee  
Dec. 13, 2013 w/late fee

If a player has paid the winter sport fee with a fall volleyball team,  
a basketball team or a co-ed volleyball team they do not have to pay again  
Indicate that on the team roster.

Schedule: Dec. 20, 2013 (online)

### To Register for This League:

1. **ROSTER MUST BE FILLED OUT IN FULL TO BE ACCEPTED!** This includes name, address and phone for ALL players on your roster. If not properly completed, you will be required to complete your roster and have it in Parks & Recreation office before your first game. Players must either sign the roster or a waiver, it is not necessary to sign both. IF A PLAYER HAS SIGNED EITHER FOR ANY PARKS & RECREATION PROGRAM SINCE APRIL 1, 2013, THEY DO NOT NEED TO SIGN AGAIN. Please make a note on the roster which league roster or waiver form they signed. Even if a player fills out a waiver form, the player's information must still be on your roster in order for the roster to be complete. A minimum of 6 players on the roster is required.
2. Each team will play a 10-game schedule on Sunday afternoons and/or Thursday nights beginning January 5, 2014, at the Veteran's Memorial Coliseum starting at 7:15 on Thursdays and 1:00 p.m. on Sundays. There will be three leagues offered: A, B and C. Please place your team in the appropriate league.  
*Coed A League teams will play on Thursday nights only.*
3. Team representatives/contacts need to be easily reached by phone.
4. The completed roster (see #1) may be brought to the Parks & Recreation office, along with registration and player fees on or before the registration deadline. Deadline to register and avoid a late fee is Wednesday, December 11, 2013. Registrations will be accepted December 12 – 13, 2013, with a \$15.00 late fee.
5. **Schedules will be available Friday, December 20, 2013, at P&R office and online [www.marshalltownparkandrec.com](http://www.marshalltownparkandrec.com)**
6. Parks & Recreation reserves the right to change the league due to number of teams participating. Make up games will be played at the best available date and time possible, which may include a date and/or time not requested by your team.
7. Every attempt to play all league games will be made if schedule allows. Park & Rec will not refund league fees if games are cancelled and not rescheduled due to, but not limited to, inclement weather, acts of God or previous scheduling at Coliseum.

## 2014 Coed Volleyball Rules

1. The following rules and regulations are set by the Parks & Recreation Department so that each individual will have a good time.
2. Do not enter the building earlier than 15 minutes before the first game.
3. The program supervisor is a member of the Parks & Recreation Department staff and should be shown the same respect as you expect to be shown in your job. He or she is the representative of the department and his or her word is final.
4. This league is officiated by the players on the floor. It is up to each team to call violations on their side of the net. Please be fair. The supervisor will keep a final score sheet but will not make calls. If in doubt on a call, play the point over. Winning team must report the score to the supervisor.
5. Poor conduct will not be tolerated. If an individual cannot maintain good sportsmanship, the Parks & Recreation Department has the right to bar them from further participation in the program.
6. Cancellation of games will be announced on KFJB, KIX and KDAO radio stations and will also be available on the P&R Information/Cancellation Line 641.754.5779. Game cancellations will also be posted on Facebook and Twitter. Make up dates will be mailed to team captains and available online.
7. Additional players may be added to the roster during P&R business hours (8:30 am-5:00 pm) providing their winter fee has been paid. Players 18 years old (out of high school) and older are eligible to play.
8. USVBA rules will be used for all league games.
9. All games will start at the scheduled time and teams have 45 minutes to play their match. The following games will start immediately after the previous match is over. If a game finishes ahead of schedule the teams may practice until 5 minutes prior to the next scheduled game. If the games are running late, the next game will start immediately even if the entire 45 minutes are not used.
10. A team may start with three players but not less than three. Less than three will constitute a forfeit. You must have at least one female to begin the game. If more arrive during the game they may enter on the next serve. Maximum players for A & B league is 6 players (3 male and 3 female), for C League is 8 players (4 male and 4 female).
11. Three games will constitute a match. The winner of two games will win the match. Rally point scoring will be used in all matches. Games one and two will be played to 25 points (win by 2 points) and game three, if necessary, will be played to 15 points (win by 2 points).
12. Each team is allowed one 1-minute time out each game. An injury to a player will not count as a time out but shall not exceed three minutes. If more time is needed a time out must be taken or the player replaced.
13. There will be a 1-minute interval between games.
14. Substitution must be done according to USVBA rules except if a rotation is used. If rotation is used the 3 substitution rule will be waived.
15. The server must call the score clearly so both teams can hear. Failure to do so will be called a no-serve and the ball will be re-served.
16. A legal serve shall be underhand, sidearm or overhand.

17. When a team hits the ball more than once, one of the hits must be made by a female player. Blocking the ball does not count as a hit. After a block, a male player may play the ball back over the net.
18. If two players hit the ball at the same time it is considered one hit and either are eligible to hit the ball again.
19. A player may not reach over the net to hit the approaching ball. They may follow through over the net but first contact must be made on their own side of the net.
20. A player may not come into contact with the net at any time. If a player touches the net it is a violation.
21. A ball hitting the ceiling and/or rafters on your side of the net is considered in play provided it falls on your side of play. If the ball hits the ceiling and/or rafters and goes to the opponent's side, the ball is out. Any ball hitting the basketball hoop, net, backboard or support is out. Any ball hitting the divider curtain, wall, stage net or scoreboards is out.
22. Spectator Rules: Due to limited seating available for spectators, Parks & Recreation encourages limited spectators. Those spectators in attendance are asked to follow the following rules.
  - All spectators will find a seat and keep it. Use the north bleachers at the Coliseum.
  - Spectators must not make any calls. Spectators must not hassle players in any way or they will be asked to leave the facility.
  - Due to no child care facilities, children not yet in middle school need to be accompanied by an adult not participating in the league. If children remain unsupervised at the facility, a forfeit may be called against the offending team.
23. Clean dry shoes are required for all participants. No exceptions. Any participant who does not provide a clean dry pair of shoes will be asked to play in their stocking feet. Those who do not comply will forfeit their teams' games for that evening.
24. Smoking is not permitted in the Coliseum or within 10 feet of any door. Alcohol is not to be consumed within the building. Intoxicated players will be asked to leave.
25. Only roster protests are allowed. The protest must be made before leaving the court. The protest must be made in writing and turned in with a \$15.00 protest fee to the program supervisor. If won, the \$15.00 will be refunded; if lost the \$15.00 will be placed into the volleyball account.
26. ANY team or player owing the Parks and Recreation Department money or not fulfilling roster requirements will not be allowed to play in any Parks & Recreation programs until the debt and all related charges are paid in full or roster requirements have been fulfilled. Each player on the roster will be suspended if a team debt is owed.
27. The Parks & Recreation department and its employees are not responsible for lost or stolen items. Secure your own clothing and valuables.
