A Storage Facility is any business or company which receives compensation, directly or indirectly, for the storing of vehicles, to include but not limited to; tow companies, body or repair shops, new and used automotive dealers, garages, service stations, repossession companies, business storing vehicles for insurance companies, etc. City ordinance requires each towing company or storage facility which stores vehicles as a result of inclusion on the NOPD Call Allocation List, under the provision of this chapter, to pay an annual, non-prorated fee of \$20 for each storage location and \$10 for each truck prior to conducting business as a participant in the New Orleans Police Department's call allocation list and/or charging any associated fees. Each participant authorization is good for one year and expires on the thirty-first day of December.
