This declaration grants an exemption from Forest Conservation Requirements for purpose of an activity conducted on an existing single lot of any size, based on §173-71.H of the Town of La Plata Forest Conservation Program. If the Owner makes application for an additional activity regulated under the Forest Conservation Ordinance on all or part of the lot within a five (5) year period, the Chief Executive Officer of The Town of La Plata shall require the Owner to satisfy requirements established in the Town of La Plata Forest Conservation Ordinance.
