- 1. Commissioner Regan Nonneman made a motion to approve the minutes and agenda. Commissioner Chevy Davidson seconded. All in favor, motion carried.
- 2. Treasurer Linda Brown presented the weekly Financial Statement.
- 3. Chuck Warner stopped by to discuss the brush law. The road and bridge foreman, Jim Fletchall had told him that if he bulldozed that he could shape and ditch the roadway. He doesn't want to doze because of the fence. The commissioners told him that he didn't have to doze. It was his choice. Mr. Warner will continue working and get the trees deared as soon as possible.

- 5. Jerry and Ann Roach stopped by to request, and were granted permission for county share of brush removal costs on CR 204/100th Rd. They also complimented the county and Kinsella Lawn Service for how nice the courtyard looks.
- 6. Road and Bridge Foreman report:
 - The CASE grader needs repaired. It is probably under warranty but there will be a trip charge. Fletchall checked to see if it would be cheaper to have it hauled to the facility for repair or have them come up. It was cheaper to have them come here, so that was decision that was made to have the repairman come here.
- 7. Clerk Owens presented the commissioner with a Resolution number 2014-01 Resolution to have Northnest Regional Council of Governments apply for district funds for solid maste collection, to sign for the Northwest Missouri Solid Waste Management District, Executive Board.
