International Arbitration Moot 2014

The LIV International Law Section is pleased to provide an opportunity for penultimate and final year university students, law graduates and young practitioners (under the age of 36 or with 5 years or less PQE) to exercise and improve their advocacy skills in an international arbitration.

WHAT IS INVOLVED

Teams comprising of no more than four members compete in two Preliminary rounds (once as Claimant and once as Respondent) to determine which four teams will progress to the Semi-Finals round.

The two winning teams will then progress through to the Grand Final which will be conducted before a panel of three arbitrators at the Melbourne Commercial Arbitration and Mediation Centre.

The Grand Final moot is followed by a celebratory cocktail party at which prizes for the Winning Team and Best Advocate are awarded, as well as certificates for all participants.

WHY PARTICIPATE

Enhance your practical problem-solving skills and gain the invaluable experience of appearing in front of national and international arbitrators. Participants will also be exposed to various procedural issues that may arise during the course of arbitration.
