## **ADOPTION OF COUNCIL RULES:**

Council President Langbehn recommended that Council hold off on the adoption of Council Rules so they may review them for any changes or clarifications.

Council Member Hawkins said he would like to make a proposal to reflect a change in Council Rules. He said there is an election every year for President and Vice-President of Council and he has always been supportive of the nominees and would do so again. However, he feels that we are denying the opportunity of others to enjoy a leadership position, and feels everyone on this Council would be competent to do so. Mr. Hawkins said that perhaps Council Rules should reflect that one can only serve a certain number of years as President or Vice President of Council allowing others the opportunity to serve in those positions. He feels this position should be rotated. Mr. Hawkins said he has been on Council 16 years and there have been two Presidents of Council, Mr. Zorn and Mr. Langbehn.

Council President Langbehn said they will discuss this at the next meeting of Council as well as any other suggestions for changes or clarifications to Council Rules.

Council President Langbehn also asked that Council Members look over last year's Committee Assignments should there be any recommendations for changes to the Committee Assignments.

Ms. Shirley reminded Mr. Hawkins that both she and Mrs. Stroud were also elected as President of Council during the time indicated by him earlier in his discussion.
