Chairman McCandless and Jetta Valentine updated the Council on the progress that has been made to prepare for Run Elevated. Run Elevated is a half marathon that begins up Little Cottonwood Canyon and will end at the Alta Canyon Recreation Center. The marathon will be held on Saturday, August 22, 2015.

### B. Adventure Week Presentation

Korban Lee addressed the City Council while he showed a PowerPoint presentation regarding the proposal for Adventure Week that is planned to take place in mid April for eight days. He stated that Adventure Week will be a week full of festivals, events, expos, competitions, and service.
