RECYCLING

Bob Stone with Republic Systems spoke of their single-stream recycling program, a subscription service which costs \$5.79/monthly for biweekly pickup. He would like the city to the service to citizens by placing it on the website and word of mouth. This will be voted on at the next commission meeting.

NEW LIBRARY BOARD MEMBER

Library Director Joanne Stanfield recommended Emily McDonald as the new library board member. This will be voted on at the next commission meeting.

BUSINESS RECRUITMENT PLAN

Strategic Planner Kelly Martin spoke of the need for retail in the city, and introduced representatives Lacy Beasley and Laura Hudson from the retail consulting firm Retail Strategies. They spoke of their range of services, a three-year plan which would cost \$100,000. The commission gave permission to put a bid out for retail consulting.

COMMISSION MEETING AUDIO ON CITY WEBSITE

Mayor Lamb was contacted by a citizen who would like to be able to listen to commission meeting audio on the city website. City Recorder Amber Sanderson advised that this is possible. The city will do this going forward. It was also mentioned that the city could look into moving commissioners' bench microphones closer, to help with sound quality.

INDUSTRIAL DRIVE INTERSECTION

Mayor Lamb introduced the topic of traffic backups at Industrial Drive, and asked if it would be possible to extend the turn lane down Industrial Drive. Public Works Director Eric Sines stated that we would have to get TDOT's permission, as it is a state road. No further action was advised.

HULSEY WELLNESS CENTER/EMPLOYEE MEMBERSHIPS

Commissioner Garver introduced the topic of starting a gym membership program for employees and spouses at Hulsey Wellness Center, at a cost of \$300 for individual employees, \$400 for employee plus spouse, with the city paying 50-60% of the cost. He suggested a six-month trial period for the program. The commission will vote at the next meeting to authorize the city to implement the six-month trial period.

POLICE DEPT. BODY CAMERAS

Vice Mayor Johnson discussed that he would like for every patrol officer to have a body camera. Chief Brian Hickman explained what that would entail, including having to replace certain equipment in patrol cars to be compatible with body cameras. He is going to bring the commission a figure for fully outfitting officers and their cars.
