#### **FICTION**

**Takedown Twenty** by Janet Evanovich: Stephanie Plum has her sights set on catching a notorious mob boss. If she doesn't take him down, he may take her out.

**King and Maxwell** by David Baldacci: Tyler Wingo receives an email from his dad – AFTER being told he is KIA in Afghanistan. Tyler hires Sean and Michelle to help him find the truth.

**Stolen** by Daniel Palmer: The reader is asked to suspend disbelief and enjoy this very fast-paced thriller about repercussions from a stolen identity.

**The Black Rider** and Other Stories by Max Brand: Western tales from the well-known and very respected author of this genre. Three short novels and one short story never printed before.


