All entry forms must be returned by December 1<sup>st</sup>. <u>NO ENTRY FEE IS REQUIRED.</u>

<u>PARADE ROUTE</u>: Beginning at Pansy and Fairmont and proceeding on Fairmont to Watters, then making a U-Turn at Watters and proceeding back up Fairmont to Pansy.

Check- In: ALL ENTRIES TO ENTER @ Pansy & KeithWhen Arriving: Go to the "Check in Table" first to sign in and pick up your number, then<br/>proceed to line up area.Line Up: 4:00 PM (You can decorate once you are in the lineup area.)Judging: Before the Parade at 6:00PMStarting Time: 7:00 PM Sharp!

### **ENTRIES:**

All entries (wagons, trucks, trailers, floats, motorcycles, etc) must be decorated and lighted. All entries are responsible for power to light their entry. You have the option to play holiday music.

### NO LIVE SANTA CLAUS. The City of Pasadena will furnish the Santa Claus. NO POLITICAL ADVERTISING.

# **RULES OF THE ROAD**

ABSOLUTELY NO THROWING OF CANDY, GUM, ETC. from any entry in the parade.

Doing so will cause immediate expulsion from the Parade. This is a City of Pasadena rule and is strictly for safety reasons. Only those participants who are walking will be allowed to pass things out to the spectators along the parade route. If there are people walking with your float, truck, etc., there will be **NO JUMPING ON & OFF ANY MOVING VEHICLE**. Walkers will not be allowed to walk beside the moving vehicles; for safety reasons they **MUST** be <u>BEHIND OR IN FRONT OF THE VEHICLES</u>. Children under 5 may walk in the parade with an adult. Children who are riding on floats, trailers, trucks, etc. must be accompanied by adults at all times.

There is to be no littering either at the line up or along the parade route. If you work on your entry at the line up, please be sure to take everything with you.

### No alcoholic beverages are allowed at the line up area or Parade Route.

Number placement will be explained at time of check in.

**ENTRY FORM** - Please complete the entire form. All entries must be received no later than 5:00 PM on December 1<sup>st</sup>.

AWARDS – Trophies in 8 different categories will be presented at Judging time (6:00 pm).

**HOLD HARMLESS DECLARATION - All** participants must sign a release holding the Pasadena Strawberry Festival, San Jacinto Day Foundation and the City of Pasadena harmless for any loss of personal injury or property damage during the parade. Each participant or legal guardian of a minor participating must sign the release. Please feel free to copy the release form enclosed for your participants if necessary. <u>Please assign someone to collect & turn in the releases at check in, if you do not send them in with your Entry Form.</u>

The Parade Committee reserves the right to reject any entry which they deem inappropriate. Groups that appear to be participating for the purpose of protesting for or against a cause are not representative this holiday celebration.

In consideration described in this agreement, I hereby **Release** and **Waive** any claim against PSF/SJDF, also agree to **Indemnify** and **Hold Harmless**, their present and former officers, directors, members, staff and agents for damages or injuries, and agree not to sue the PSF/SJDF and any other person, firm, or corporation bound to defend or pay judgments against them, for any and all losses, claims, demands, or causes of actions, costs of defense or settlement, including bodily injury or death caused by **Negligence**, **Gross Negligence**, **Per Se Liability** and/or **Liability** under the **DTPA**, of PSF/SJDF or whatever other reason. I further agree that the PFS/SJDF shall not be liable to me, my family, or my guests, for personal injury, property damage, or any other losses. I understand that this Release and Indemnity Agreement shall be binding on my heirs, executors, successors and assigns. This release agreement includes, but is not limited to losses caused by any of the following: **Negligence**, **Gross Negligence**, **Negligence Per Se**, and/or **Strict Liability**, of PSF/SJDF; acts under the Texas Deceptive Trade Practices Act ("DTPA") or acts of any other persons, guests, theft, burglary, assault, crimes, fire, water, wind, rain, smoke and/or risks and hazards both wild and domestic that may be diseased and/or potentially dangerous, persons with firearms both on and off the Pasadena Fairgrounds premises, and the driving or riding in any vehicles, whether belonging to PSF/SJDF or to other persons. **To Indemnify** means to agree to assume the liability in a situation thereby relieving the other party of responsibility.

I grant permission to be Photographed or Interviewed in connection with PSF/SJDF. Such photograph or interviews may be used for television, film, video, visual, graphic or printed media to demonstrated the nature of the PSF/SJDF and to further the aims of PSF/SJDF.

I agree that this **Release**, **Indemnify Agreement**, **Hold Harmless** will be governed by the laws of Texas, and that jurisdiction and venue for resolution of any dispute regarding this agreement shall lie in a Texas State Court in Harris County, Texas. I agree to the terms and conditions above, and acknowledge receipt of this agreement.


