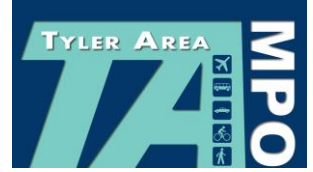

The Tyler Area Metropolitan Planning Organization (MPO) is responsible for transportation planning within the Tyler Metropolitan Area which includes Tyler, Hideaway, Lindale, New Chapel Hill, Noonday, Whitehouse and Bullard. The purpose of the Transportation Improvement Program (TIP) is to list the transportation improvements that are scheduled to be implemented within the 2015 through 2018 fiscal years. A public comment period will be held from February 26, 2015 – March 8, 2015 for revisions to the TIP, which will be considered for adoption at the MPO Policy Committee Meeting on March 26, 2015 at 2:00 p.m.

Board, Keep Tyler Beautiful Board, Parks Board, Planning and Zoning Commission, Tyler Public Library Board, Traffic Safety Board, Tyler Area Metropolitan Planning Organization Policy Board and Zoning Board of Adjustment will be present at the *Tyler Area Metropolitan Planning Organization 2015 – 2018 Transportation Improvement Program Open House on Thursday, February 26, 2015 between 5:30 and 6:30 p.m.*, located at the *Tyler Development Center, 423 West Ferguson Street, Tyler, Texas.*
